- (a) Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore;
- (b) Schedule 2 to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore:
