THE TAMESIDE METROPOLITAN BOROUGH (WELLINGTON ROAD, ASHTON-UNDER-LYNE) (BUS STAND) ORDER 2009

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the said Act of 1984 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. (1) In this Order:-

"bus stand" means any area of carriageway intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025.1, 1025.3, or 1025.4 in Schedule 6 of the Traffic Signs Regulations and General Directions 2002, and with signs complying with diagram 975 in Schedule 5 of the Traffic Signs Regulations and General Directions 2002.

"bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002.

- (2) except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 2. Save as provided in Article 3 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle other than a bus to stop or wait on any part of the bus stand specified in the Schedule to this Order
- 3. Nothing in Article 2 to this Order shall render it unlawful to cause or permit any vehicle to wait on any of the carriageways referred to therein for so long as may be necessary to enable:
 - the vehicle if it cannot be conveniently used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the road comprising or including that carriageway; or
 - (iv) the laying, erection, alteration or repair in, or the land adjacent to, the carriageway of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.

- in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
- (b) the vehicle to be used for Fire Brigade, Ambulance or Police purposes;
- (c) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000; or
- (d) in any case where when the person in control of the vehicle:-
 - (a) is required by law to stop:
 - (b) is obliged to stop in order to avoid an accident; or
 - (c) is prevented from proceeding by circumstances outside his control
- (e) a bus waiting on any carriageway in a designated bus stop area.
- 4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.
- 5 This Order will come into operation on the 2nd day of July 2009 and may be cited as
