THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET, MARKET HALL SERVICE ROAD AND TOWN HALL SERVICE ROAD, ASHTON-UNDER-LYNE) (ONE-WAY TRAFFIC) ORDER 2009

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1) and 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. Save as provided in Articles 2 and 3 to this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to proceed in any of the lengths of roads specified in Column 1 of the Schedule to this Order in a direction other than that specified in relation to that length of road in Column 2 of that Schedule.
- 2. Nothing in Article 1 of this Order shall apply to the driving of any mechanical road cleansing vehicle used in pursuance of statutory powers or duties.
- 3. Nothing in Article 1 of this Order shall apply to the driving of any vehicle being used for Ambulance, Fire Brigade or Police purposes if the observance of any provision of this Order would hinder the use of the vehicle for the purpose on which it is being used on that occasion.
- 4. THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET, MARKET HALL SERVICE ROAD AND TOWN HALL SERVICE ROAD, ASHTON-UNDER-LYNE) (ONE-WAY TRAFFIC) ORDER 2000 is hereby revoked.

This Order will come into operation on 30th November 2009 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET, MARKET HALL SERVICE ROAD AND TOWN HALL SERVICE ROAD, ASHTON-UNDERLYNE) (ONE-WAY TRAFFIC) ORDER 2009".
