THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

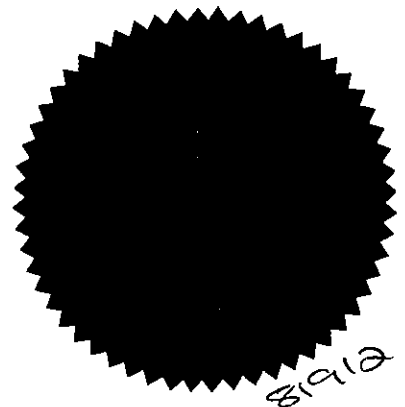
- 1 The Greater Manchester County (Area South of Stamford Street Central Ashton-under-Lyne) (Restriction of Waiting) (County) Order 1982 shall have effect as though in Schedule 1 to that Order the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides of lengths of road specified in Part 2 of the Schedule to this Order substituted therefore.
