- "THE GREATER MANCHESTER COUNTY (WINDMILL LANE, DENTON) (WEIGHT RESTRICTION) (BOROUGH) ORDER 1975" is hereby revoked.
- 7. "The Greater Manchester County (Church Brow, Littlemoor Road and Gorsey Brow, Longdendale) (Prohibition of Commercial Vehicles of Over 3 tons) Order 1976" is hereby revoked.
- 8. "The Greater Manchester County (Mossley Station Bridge, Mossley) (Weight Restriction) (County) Order 1978" is hereby revoked.
- 9. "THE TAMESIDE METROPOLITAN BOROUGH (CROMPTON STREET, HURST BANK ROAD, ASHTON-UNDER-LYNE) (GOODS VEHICLE RESTRICTION) ORDER 1992" is hereby revoked.
