(MARKET STREET AND MARKET HALL SERVICE ROAD,
ASHTON-UNDER-LYNE)
(RESTRICTION OF ACCESS) ORDER 2013

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1) and 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. In this Order:-

"motor vehicle" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.

2. Save as provided in Article 3 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle to enter or proceed in the lengths of roads specified in the Schedule to this Order other than for the purpose of loading and unloading to premises adjacent to the side of lengths of road specified in the Schedule to this Order.
3. Nothing in Article 2 to this Order shall render it unlawful to cause or permit any vehicle to enter or proceed in the lengths of roads specified in the Schedule to this Order so long as may be necessary to enable:-
- (a) the removal of any obstruction to traffic;
 - (b) Police, Fire Brigade and Ambulance purposes;
 - (c) in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) the maintenance, improvement or reconstruction of the said sides of lengths of roads;
 - (e) the laying, erection, alteration or repair in, or the land adjacent to, the sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any electronic communications network as defined in the Communications Act 2003.
 - (f) building, industrial or demolition operations;
 - (g) the vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000.
4. THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET AND MARKET HALL SERVICE ROAD, ASHTON-UNDER-LYNE) (RESTRICTION OF ACCESS) ORDER 2009 is hereby revoked.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

The Order shall come into operation on the 20 day of May 2013 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET AND MARKET HALL SERVICE ROAD, ASHTON-UNDER-LYNE) (RESTRICTION OF ACCESS) ORDER 2013".
