

THE GREATER MANCHESTER COUNTY
(MANCHESTER ROAD NORTH/MANCHESTER ROAD
SOUTH, DENTON) (ONE WAY TRAFFIC)
(COUNTY) ORDER 1981

The Greater Manchester County Council in exercise of their powers under Section 1(1) (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

- 1 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2 Save as provided in Article 3 of this Order no person shall cause or permit any vehicle to proceed in the lengths of road specified in column 1 of the schedule to this Order in a direction other than that specified in relation to those lengths of road in column 2 of that schedule.
- 3 Nothing in Article 2 of this Order shall apply to any mechanical road cleansing vehicle being used in pursuance of statutory powers or duties.
- 4 This Order shall come into operation on the 1st February, 1982 and may be cited as The Greater Manchester County (Manchester Road North/Manchester Road South, Denton) (One Way Traffic) (County) Order 1981.

Manchester Road South, Denton from Seymour Street to the westerly kerbline of Oldham Street	from Seymour Street to the westerly kerbline of Oldham Street.

The link road between Manchester Road North and Holland Street opposite the southern end of Foxhall Road

from Manchester Road North to Holland Street.

Holland Street, Denton from the easterly kerbline of Foxhall Road to Manchester Road North

from the easterly kerbline of Foxhall Road to Manchester Road North.

The link road between Manchester Road South and Heaton Street, 80 metres west of Seymour Street

from Manchester Road South to Heaton Street

Heaton Street, Denton from a point 10 metres east of Manchester Road South to Manchester Road South

from a point 10 metres east of Manchester Road South to Manchester Road South
