

THE GREATER MANCHESTER COUNTY

(CATHERINE STREET, DENTON)

(STREET PLAYGROUND) ORDER 1976

THE BOROUGH COUNCIL OF TAMESIDE (hereinafter referred to as "The Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Greater Manchester (hereinafter referred to as the "said County Council") in exercise of the powers of the said County Council under Section 26 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 (which said Act of 1967 so amended is hereinafter referred to as the "Act of 1967") hereby make the following Order:-

1. Save as provided in Article 2 of this Order no person shall cause or permit any vehicle to proceed between the hours of 8.00 and sunset in that length of Catherine Street, Denton between its junctions with Oldham Street and Derby Street, Denton.
2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in any of the road referred to in that Article if the vehicle is being used:-
  - (a) for the conveyance of person, goods or merchandise to or from any premises situated on or adjacent to that road.
  - (b) in connection with any building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic in that road the maintenance improvement or reconstruction of that road, or the laying, erection alteration or repair in or adjacent to that road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraphic Act 1878.
3. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 1st day of August 1976 and may be cited as THE GREATER MANCHESTER COUNTY (CATHERINE STREET, DENTON) (STREET PLAYGROUND) ORDER 1976.

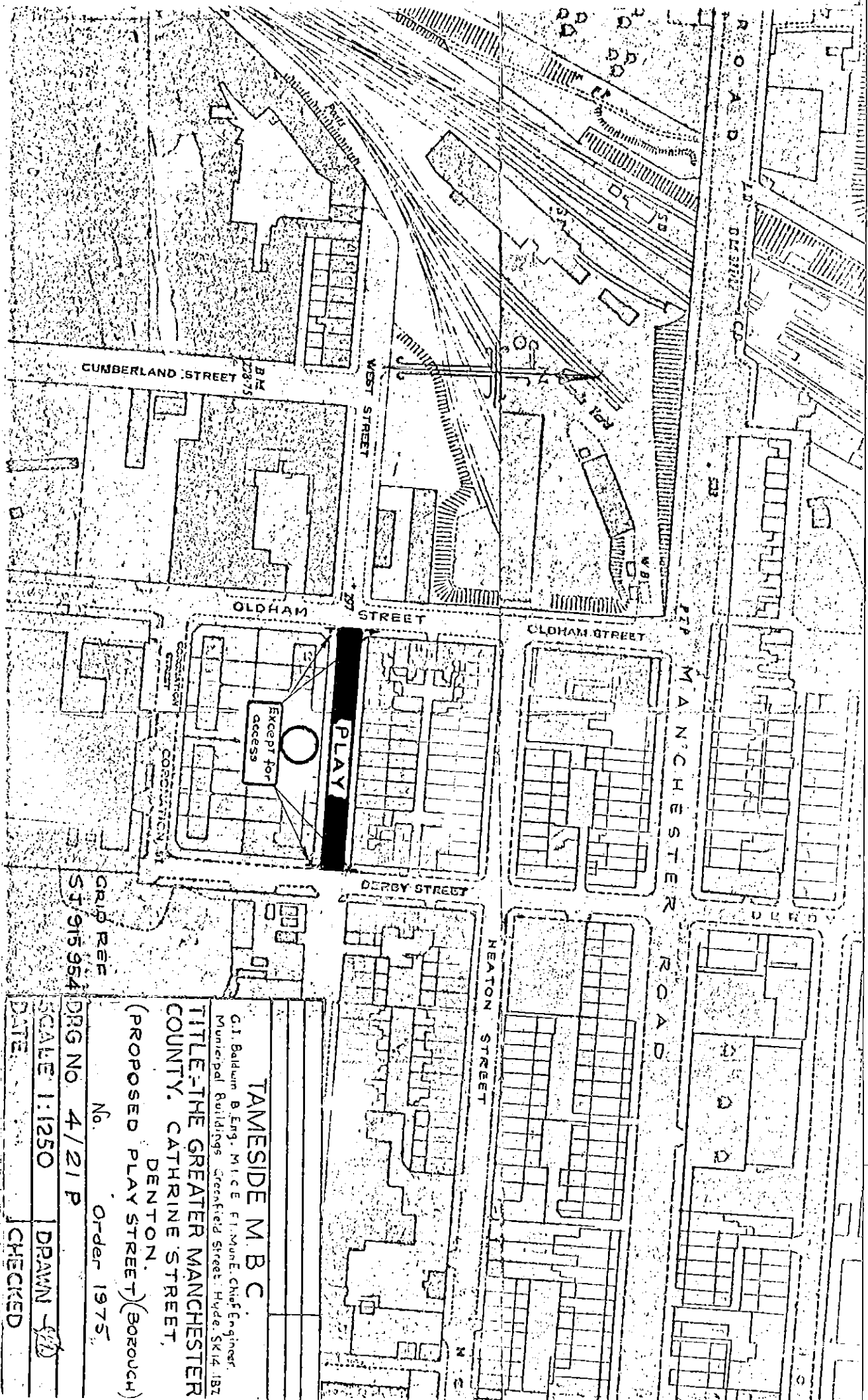
