
# THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE TAMESIDE) (PROHIBITION AND RESTRICTION OF WAITING)(NO.1)(COUNTY) (AMENDMENT NO.1) ORDER 2003

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the said Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE TAMESIDE) (PROHIBITION AND RESTRICTION OF WAITING) (NO.1) (COUNTY) ORDER 1982 shall have effect as though that Order is amended in so far as:-
  - (i) in Schedule 1 to that Order the sides of lengths of road specified in part 1 of Schedule 1 to this Order shall be deleted therefrom and the sides of lengths of roads specified in part 2 of Schedule 1 to this Order included therein.
  - (ii) in Schedule 2 to that Order the sides of lengths of road specified in Schedule 2 to this Order shall be deleted therefrom.
- 2. This Order will come into operation on the 30<sup>th</sup> day of September 2004 and may be cited as "THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE TAMESIDE) (PROHIBITION AND RESTRICTION OF WAITING) (NO.1)(COUNTY) (AMENDMENT NO.1) ORDER 2003".
