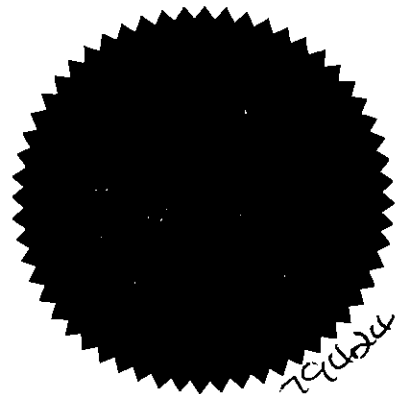
**THE TAMESIDE METROPOLITAN BOROUGH  
(A627/A6017, NORTH-SOUTH ROUTE TAMESIDE)  
(PROHIBITION AND RESTRICTION OF WAITING)(NO.1)(COUNTY)  
(AMENDMENT NO.4)ORDER 2006**

**THE TAMESIDE METROPOLITAN BOROUGH COUNCIL** in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE TAMESIDE)(PROHIBITION AND RESTRICTION OF WAITING)(NO.1)(COUNTY) ORDER 1982 shall have effect as though :-
  - (a) In Schedule 1 to that Order the sides of lengths of road specified in Part 1 of Schedule 1 to this Order is deleted, and the sides of lengths of road specified in Part 2 of Schedule 1 to this Order substituted therefore.
  - (b) In Schedule 2 to that Order the sides of lengths of road specified in Part 1 of Schedule 2 to this Order is deleted, and the sides of lengths of road specified in Part 2 of Schedule 2 to this Order substituted therefore.
2. Subject to the provisions of Article 2 to this Order the prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

The Order shall come into operation on the 12<sup>th</sup> day of April 2007 and may be cited as

**Ashton Road, Denton**  
(east side)

from a point 15 metres south of Turner Street to a point  
15 metres north of Turner Street.

### **PART 2 (substitution)**

**Ashton Road, Denton**  
(east side)

from a point 15 metres south of Turner Street to its junction  
with Hartford Street.

from its junction with Hartford Street to a point 36 metres  
north of that junction.
