## THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC REGULATION ORDERS DENTON) (AMENDMENT) ORDER 2007

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1 The GREATER MANCHESTER COUNTY (WILTON STREET, DENTON) (RESTRICTION OF WAITING) ORDER 1985 shall have effect as though in the Schedules to the Order the words "Holland Street" wherever they appear, were deleted
- 2 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (ROSEHILL DENTON) (PROHIBITION OF WAITING) ORDER 1989 shall have effect as though in the Schedule to the Order the words "Rosehill" were deleted and the words "Rose Hill" substituted".
- 3 The TAMESIDE METROPOLITAN BOROUGH (GRESHAM STREET, DENTON) (PROHIBITION OF WAITING, LOADING AND UNLOADING) ORDER 1994 shall have effect as though in Article 4 (2) the words "Schedule 5" are to be deleted and the words "Schedule 1" substituted.
- 4 The TAMESIDE METROPOLITAN BOROUGH (STOCKPORT ROAD, DENTON) (PROHIBITION OF WAITING AND LOADING AND UNLOADING) ORDER 1987 shall have effect as though in Article 4 to the Order the word "(County" were deleted and the words "(County) Order 1982" substituted.
- 5 The TAMESIDE METROPOLITAN BOROUGH (MARKET STREET AND VICTORIA STREET, DENTON) (RESTRICTION OF ACCESS AND TRAFFIC REGULATION) ORDER 2000 shall have effect as though the restrictions on Market Street (east side) and (west side) were deleted from Schedule 2.
- The TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS)
  (DENTON) PROHIBITION OF WAITING ORDER 2006 shall have effect as though the citation to the Order were amended to read THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS) (DENTON)
