# THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, DENTON) (REVOCATION) ORDER 2008

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, DENTON) (PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING) ORDER 2008 shall have the effect as though in Schedule 2 to that Order the sides of length of road "Walker Street" were deleted therefrom.
- THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, DENTON) (PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING) ORDER 2008 shall have the effect as though in Schedule 5 to that Order the sides of length of road "Lupton Street" and "Nelson Street" were deleted therefrom.
- 3. THE GREATER MANCHESTER COUNTY (LAKE ROAD, DENTON)
  (PROHIBITION OF WAITING) ORDER 1983 shall have the effect as though
  in the Schedule to that Order the side of lengths of roads in Schedule 1 to this
  Order were deleted therefrom and the sides of length of road in Schedule 2 to
  this Order were substituted therefore.
- 4. THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE TAMESIDE) (PROHIBITION AND RESTRICTION OF WAITING) (NO. 1) (COUNTY) ORDER 1982 shall have the effect as though in Schedule 8 to that Order the following sides of lengths of roads were deleted therefrom:-

Lupton Street

north side from a point 23 metres east of its junction with Ashton Road for a distance of 50

feet in an easterly direction.

**Lupton Street** 


south side from a point 23 metres east of its junction with Ashton Road for a distance of 15

feet in an easterly direction.

The Order shall come into operation on the 2<sup>nd</sup> day of October 2008 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, DENTON) (REVOCATION) ORDER 2008".

Lake Road - north and west sides from its junction with York Road to the cul-de-sac end at Ashton Road.

Lake Road - south side from the cul-de-sac end at Ashton Road for a distance of 30m in an easterly direction including the turning

head.
