

**TAMESIDE METROPOLITAN BOROUGH COUNCIL****THE TAMESIDE METROPOLITAN BOROUGH  
(STOCKPORT ROAD, DENTON)  
(40 MPH SPEED LIMIT AND PART REVOCATION) ORDER 2010**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 82(2), 83(2), 84(1)(a) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order: —

1. The length of road specified in Schedule 1 to this Order shall be a restricted road for the purposes of Section 81 of the Road Traffic Regulation Act 1984.
2. No person shall drive a motor vehicle at a speed exceeding 40mph on the length of road specified in Schedule 2 to this Order.
3. The Greater Manchester County (Stockport Road, Denton/Ashton Road, Bredbury) (40 mph Speed Limit) (County) Order 1983 is hereby revoked insofar as it applies to the length of Stockport Road Denton within the Metropolitan Borough of Tameside.
4. The Tameside Metropolitan Borough (Stockport Road, Denton) (Restricted Road) Order 2007 is hereby revoked.

This Order will come into operation on 1<sup>st</sup> April 2010 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (STOCKPORT ROAD, DENTON) (40 MPH SPEED LIMIT AND PART REVOCATION) ORDER 2010"

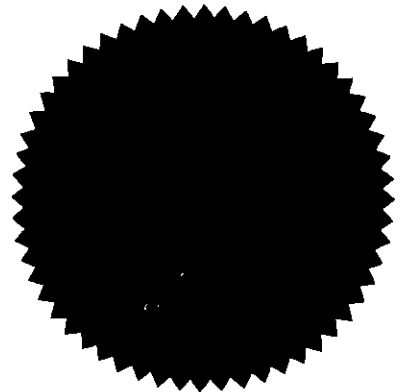
