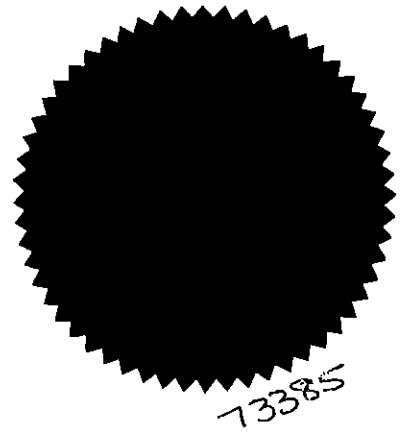
**THE TAMESIDE METROPOLITAN BOROUGH COUNCIL** in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the said Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. THE GREATER MANCHESTER COUNTY (GREENSIDE LANE, MANOR ROAD, CHAPPELL ROAD AND SCOTT ROAD JUNCTION, DROYLSDEN) (PROHIBITION OF WAITING) (BOROUGH) ORDER 1977 shall have effect as though the Schedule to that Order is amended in so far as the sides of lengths of roads specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides of lengths of roads specified in Part 2 of the Schedule to this Order substituted therefore. DRO (11)
2. THE TAMESIDE METROPOLITAN BOROUGH (GREENSIDE LANE / SHELLEY GROVE, DROYLSDEN) (PROHIBITION OF WAITING) ORDER 1992 is hereby revoked. DRO (34)
3. This Order will come into operation on the 23<sup>rd</sup> day of November 2000 and may be cited as "THE GREATER MANCHESTER COUNTY (GREENSIDE LANE, MANOR ROAD, CHAPPELL ROAD AND SCOTT ROAD JUNCTION, DROYLSDEN) (PROHIBITION OF WAITING) (BOROUGH) (AMENDMENT No.1) ORDER 2000".

### **Part 1 (Deletion)**

- Greenside Lane - north side - from its junction with Scott Road to a point 40 metres south-east of that junction
- south side – from its junction with Scott Road to a point 60 metres south-east of that junction

### **Part 2 (Substitution)**

- Greenside Lane - north side – from its junction with Scott Road to a point 190 metres south-east of that junction
- south side – from its junction with Scott Road to a point 150 metres south-east of that junction
- Shelley Grove - south-west side – from its junction with Greenside Lane to a point 15 metres south-east of that junction
- north-east side – from its junction with Greenside Lane to a point 10 metres south-east of that junction.
