THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

THE GREATER MANCHESTER COUNTY (CAVENDISH STREET / KING STREET / VICTORIA ROAD / DUKINFELD ROAD AND SIDE STREETS, ASHTON-UNDER-LYNE / DUKINFELD / HYDE) (PROHIBITION AND RESTRICTION OF WAITING) (COUNTY) ORDER 1985 shall have effect as though

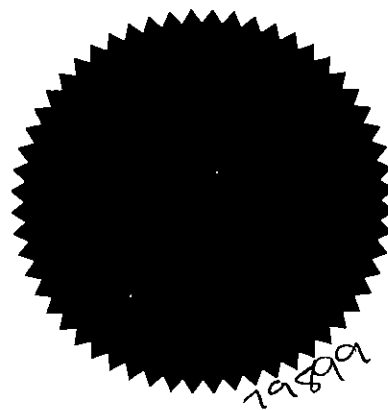
- (a) Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- (b) Schedule 2 to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore

The Order shall come into operation on the 18th day of October 2007 and may be cited as

Victoria Road A627 (West side)	from a point 20m south of the southerly kerbline of Wood Street for a distance of 85m in a southerly direction
Victoria Road A627 (East side)	from a point 120 m south of the southerly kerbline of Wood Street to a point 165 m south of that junction
Dukinfield Road A627 (West side)	from a point 25m west of Newton Street to its junction with Edward Street

Part 4 (substitution)

Victoria Road A627 (West side)	from a point 20 metres south of the southerly kerbline of Wood Street for a distance of 65 metres in a southerly direction
Victoria Road A627 (East side)	from a point 120 metres south of the southerly kerbline of Wood Street to a point 170 metres south of that junction
Dukinfield Road A627 (South side)	from a point 25 metres west of Newton Street to its junction with Edward Street


