

BOROUGH OF HYDE (CROOK STREET) (PROHIBITION OF WAITING)  
ORDER, 1965.

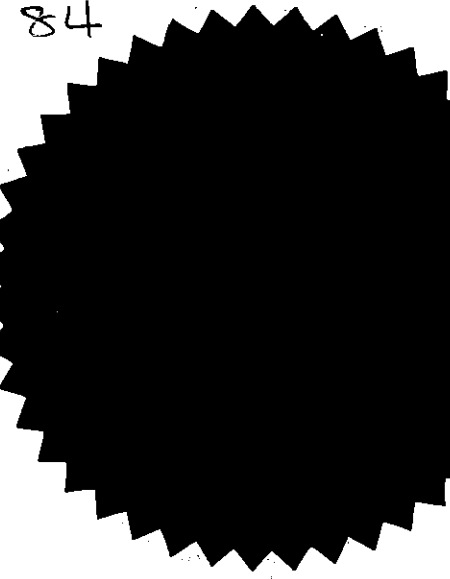
The Hyde Borough Council in exercise of the powers conferred upon them by sub-sections (1) (2) and (3) of Section 26 and sub-section (4) of Section 27 of the Road Traffic Act, 1960, and of all other powers then enabling in that behalf make the following Order.

1. Save as provided in Article 2 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform cause or permit any vehicle to wait in the lengths of Crook Street in the Borough of Hyde, specified in the Schedule hereto.
2. Nothing in Article 1 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of road referred to in that Article for so long as may be necessary:-
  - (a) to enable a person to board or alight from the vehicle;
  - (b) to enable goods to be loaded on to or unloaded from the vehicles
  - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraph line as defined in the Telegraph Act, 1878;
  - (d) to enable any vehicle owned by a Funeral Director or owner of funeral vehicles to be used as part of a funeral cortege or otherwise in connection with a funeral.
3. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the Road Traffic Act, 1960, or by or under any other enactment.
4. The Interpretation Act, 1889, shall apply to the interpretation of an Act of Parliament.
5. The Order shall come into operation on the **FIRST** day of **DECEMBER** 1965, and may be cited as "The Borough of Hyde (Crook Street) (Prohibition of Waiting) Order, 1965".

SCHEDULE.

Lengths of road within the Borough of Hyde:-  
 Crook Street (Western Side) between its junctions with Union Street and Reynold Street.  
 Crook Street (Eastern Side) for a distance of 65 yards in a southerly direction from its junction with Reynold Street.
