(AMENDMENT NO 1) (EXPERIMENTAL) ORDER 1997

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 of the Act hereby makes the following Order:-

- 1 This Order shall come into operation on the 27th February 1997 and may be cited as **"THE TAMESIDE METROPOLITAN BOROUGH (HYDE TOWN CENTRE NORTHERN CIRCULATION) (TRAFFIC REGULATION) (COUNTY) (AMENDMENT NO 1) (EXPERIMENTAL) ORDER 1997"**
- 2 In this Order :-

"taxi" has the same meaning as in Section 37 of the Town Police Clauses Act 1847 or any similar enactment:

"pedal cycle" means a pedal bicycle or pedal tricycle not being in either case capable of being mechanically propelled:
- 3 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 4 **THE GREATER MANCHESTER COUNTY (HYDE TOWN CENTRE NORTHERN CIRCULATION) (TRAFFIC REGULATION) (COUNTY) ORDER 1980** is hereby amended as follows :-
 - (1) In article 2(1) of that Order "taxi" and "pedal cycle" shall be added and shall have the meaning as described in Article 2 to this Order.
 - (2) in Article 2(1) to that Order, definitions for "scheduled express carriage", "school bus", "works bus" and "stage carriage", shall be deleted therefrom and the following substituted therefor:-

"bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 1994.
 - (3) Article 7 to that Order is deleted therefrom and the following substituted therefor:-

7. Save as provided in Article 10 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform or a traffic warden, cause or permit any vehicle other than a taxi, bus or pedal cycle to enter, proceed or wait in the bus lane otherwise than for the purpose of crossing it.

- (4) Article 8 to that Order is deleted therefrom and the following substituted therefore :-


8. Save as provided in Article 9 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform or a traffic warden, cause or permit any vehicle other than a taxi, bus or pedal cycle to enter, proceed or wait in the bus lane otherwise than in a westerly direction.

- (5) Article 9 to that Order is deleted therefrom and the following substituted therefore :-

9. Save as provided in Article 10 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform or a traffic warden, cause or permit any vehicle to proceed along New Beech Street in the area of carriageway north of the bus lane otherwise than in an easterly direction : provided that the foregoing provision shall not apply so as to prevent any person causing or permitting any such taxi, pedal cycle or a bus which is proceeding in a westerly direction in the bus lane to cross over the white line if it is necessary to do so in order to overtake a vehicle that is stationary in the bus lane.
