
# TAMESIDE METROPOLITAN BOROUGH (HYDE TOWN CENTRE BY-PASS) (PROHIBITION OF WAITING AND LOADING AND UNLOADING) (AMENDMENT No.1) ORDER 1999

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the said Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. THE TAMESIDE METROPOLITAN BOROUGH (HYDE TOWN CENTRE BY-PASS) (PROHIBITION OF WAITING AND LOADING AND UNLOADING) ORDER 1987 shall have effect as though the Schedule to that Order is amended in so far as the side of length of road specified in Part 1 of the Schedule to this Order was deleted therefrom and the sides of lengths of road specified in Part 2 of the Schedule to this Order substituted therefore.
- 2. This Order will come into operation on the 30<sup>th</sup> day of April 1999 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (HYDE TOWN CENTRE BY-PASS) (PROHIBITION OF WAITING AND LOADING AND UNLOADING) (AMENDMENT No.1) ORDER 1999".
