 - (i) in Schedule 1 to that Order the sides of lengths of roads specified in part 1 of Schedule 1 to this Order shall be deleted therefrom and the sides of lengths of roads specified in part 2 of Schedule 1 to this Order included therein.
 - (ii) in Schedule 2 to that Order the sides of lengths of roads specified in Schedule 2 to this Order shall be included therein.

(iii) item 15 to that Order shall include the following:-

Great Norbury Street, Hyde.

east side from Boardman Street to a point 15 metres south of Greenfield Street.

Jackson Street (south west side) from its junction with Corporation Street to its junction with Greenfield Street.

Water Street (south west side) from its junction with the south easterly kerbline of Greenfield Street to its junction with Cross Street.
