THE TAMESIDE METROPOLITAN BOROUGH
(ST. JOHN'S DRIVE, HYDE)
(SCHOOL ENTRANCE PROHIBITION OF STOPPING) ORDER 2003

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. In this Order:-

"school entrance area" means any area of carriageway of a specified road, which is comprised within and indicated by a road marking complying with diagram 1027.1 in Schedule 6 of the Traffic Signs Regulations and General Directions 2002:

"specified hours" means the hours between 8am and 5pm on Monday to Friday inclusive.


"specified road" means any road or length of road specified in the Schedule to this Order:

2. Save as provided in Article 3 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to stop during the specified hours in a school entrance area.
3. Nothing in Article 2 shall render it unlawful for any person to cause or permit any vehicle to stop in a school entrance area:-
- (a) if the vehicle is being used for the removal of any obstruction to traffic;
 - (b) if the vehicle is being used in the service of a local authority or any other authority in exercise of statutory powers or duties and whilst being so used in such service or in such connection it is necessary for the vehicle to wait in the school entrance area;
 - (c) if the vehicle is being used for police, fire brigade or ambulance purposes; or
 - (d) in any case where the person in control of the vehicle:-
 - (i) is required by law to stop;
 - (ii) is obliged to stop so as to prevent an accident; or
 - (iii) is prevented from proceeding by circumstances beyond his control.

The Order shall come into operation on the 24th day of April, 2003 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (ST. JOHN'S DRIVE, HYDE) (SCHOOL ENTRANCE PROHIBITION OF STOPPING) ORDER 2003".

SCHEDULE

(No stopping Monday - Friday, 8am – 5pm in School Entrance Area)

St. John's Road, Hyde.
(north westerly side)

- from a point 8 metres north east of its junction with the south westerly boundary of property No. 31 Sidley Place in a north easterly direction upto and including its cul-de-sac end.

(south easterly side)

- from a point 1 metre north east of its junction with the south westerly boundary of property No. 56 St. John's Road in a north easterly direction to its cul-de-sac end.
