## THE TAUNTON DEANE BOROUGH (NORTH OF THE RAILWAY AREA, TAUNTON) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 2002

## Amendment No. 13 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000

The Taunton Deane Borough Council (hereinafter referred to as ("the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Somerset in exercise of the powers of the said County Council under Sections 1(1), 2(1) to (2), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order shall come into operation on 27 May 2002 and may be cited as "The Taunton Deane Borough (North of the Railway Area, Taunton) (Prohibition and Restriction of Waiting) Order, 2002".
- 2. In Schedule 1 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000 there shall be deleted the following:-

"Grove Terrace

- (a) On the northern side from the junction with Kingston Road westward for a distance of 18m;
- (b) From a point opposite the common boundary of Nos. 2/3 westward for the remainder of its length.

Thomas Street

- (a) On the east side northward from the junction with Grove Terrace;
- (b) On the north side (the cul-de-sac);
- (c) On the west side for a distance of 3m from the front edge of the pavement on the north side."
- In Schedule 1 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000 there shall be inserted the following:-

"Grove Terrace

- (a) On both sides from the junction with Kingston Road westward for a distance of 20m;
- (b) On the north side from the junction with Thomas Street eastward for a distance of 5m.

Railway Street

- (a) On the north side from the junction with Kingston Road westward to the junction with Thomas Street;
- (b) On the south side from the junction with Kingston Road westward to a point 15m west of the frontage of No. 35 Thomas Street.

Thomas Street

- (a) On the east side:-
- (i) from the junction with Railway Street northward for a distance of 10m;
- (ii) northward from the junction with Grove Terrace.
- (b) On the north side (the cul-de-sac)."
- In Schedule 2 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000 there shall be deleted the following:-

"Grove Terrace

On the south side:-

- (i) from the junction with Kingston Road westward for a distance of 18m;
- (ii) from the junction with Thomas Street eastward for a distance of 11m.

Thomas Street

On the east side from the junction with Grove Terrace southward for the whole length."

5. In Schedule 3 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000 there shall be deleted the following:-

"Thomas Street

On the east side from the junction with Railway Street to a point 15m south of the junction with Grove Terrace."

6. In Schedule 4 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000 there shall be deleted the following:-

"Grove Terrace

On the north side from a point 18m west of the junction with Kingston Road westward to a point opposite the common boundary of Nos. 2/3.

Railway Street

- (a) On the north side from the junction with Kingston Road to the junction with Herbert Street;
- (b) On the south side from the junction with Kingston Road to the junction with Thomas Street.

Thomas Street

On the west side from the junction with Railway Street northward for a distance of 24m."

7. In Schedule 4 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order 2000 there shall be inserted the following:-

"Grove Terrace

- (a) On the north side from a point 20m west of the junction with Kingston Road westward to a point 5m east of the junction with Thomas Street:
- (b) On the south side from the common boundary of Nos. 1/2 westward to the junction with Thomas Street.

Railway Street

On the north side from the junction with Thomas Street westward to the junction with Herbert Street.

Thomas Street

(a) On the east side from a point 10m north of the junction with Railway Street northward to the junction with Grove Terrace;

(b) On the west side from the junction with Railway Street northward to the southern boundary of No. 1".

In Schedule 9 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Street in Taunton) Order 2000 there shall be inserted the following:-

"Grove Terrace

On the south side from a point 20m west of the junction with Kingston Road westward to the common boundary of Nos. 1/2.

Railway Street

On the south side from a point 15m west of the frontage of No. 35 Thomas Street westward to the junction with Herbert Street."

9. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any Regulation made or having effect as if made under the Act or by or under any other enactment.
