## THE TAUNTON DEANE BOROUGH (PART OF THE ST AUGUSTINE AREA, TAUNTON) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 2001

Amendment No.7A to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2001

The Taunton Deane Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act, 1972 with the County Council of Somerset in exercise of the powers of the said County Council under Sections 1(1), 2(1) to (2), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order shall come into operation on 10 December 2001 and may be cited as "The Taunton Deane Borough (Part of the St Augustine Area, Taunton) (Prohibition and Restriction of Waiting) Order, 2001".
- In Schedule 1 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order 2000, there shall be deleted the following:-

"Eastbourne Road

On both sides:-

- (i) from the junction with East Reach northward for a distance of 15m;
- (ii) from the junction with St Augustine Street south-eastward to the common boundary of Nos. 31/32.

Haydon Road

On both sides:-

- (i) from the junction with East Reach northward for a distance of 20m;
- (ii) from the junction with Winchester Street south-eastward to the common boundary of Nos. 15/16.

Laburnum Street

On the south-eastern side from the junction with Stephen Way north-eastward for a distance of 5m.

- (a) On both sides:-
- (i) from the junction with Priory Avenue south-eastward to the common boundary of Nos. 66/68;
- (ii) from the common boundary of Nos. 3/5 south-eastward for a distance of 27m;

(iii) from the junction with Priory Bridge Road south-eastward for a distance of 30m.

- (b) On the north-east side from the junction with Priory Avenue north-westward to the eastern boundary of No.77:
- (c) On the south-west side from the junction with Priory Avenue north-westward to a point opposite the common boundary of Nos.77/79.

On both sides from the junction with Stephen Way north-eastward for a distance of 5m.

- (a) On both sides from the junction with the Duke Street Flats Access Road north westward for a distance of 5m;
- (b) On the south-western side from the junction with Laburnum Court north-westward for a distance of 7m;
- (c) On the north-eastern side from the junction with Stephen Street:-
- (i) south-eastward for a distance of 5m;
- (ii) north-westward for a distance of 5m;
- (d) On the north-eastern side from the junction with Laburnum Street south-eastward for a distance of 5m.
- (a) On both sides:-
  - (i) from the junction with Haydon Road north-westward to the common boundary of Nos. 4/6:
- (ii) from the junction with Priory Bridge Road south-eastward for a distance of 30m.
- (b) On the north-east side:-
- (i) from the junction with Priory Avenue north-westward to the common boundary of Nos. 74/76;

Stephen Street

Stephen Way

Winchester Street

- (ii) from the junction with Priory Avenue south-eastward for a distance of 18m.
- (c) On the south-west side:-
- (i) from the junction with Priory Avenue north-westward for a distance of 35m;
- (ii) from the junction with Priory Avenue south-eastward for a distance of 15m."
- 3. In Schedule 1 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000, there shall be inserted the following:-

"Eastbourne Gate

On both sides from the junction with Haydon Road north-eastward to the common boundary of Nos.1/3.

Eastbourne Road

- (a) On the western side:-
- (i) from the junction with St Augustine Street south-eastward to a point opposite the common boundary of Nos.31/32; (ii) from the junction with East Reach
- (ii) from the junction with East Reach north-westward for a distance of 20m;
- (b) On the eastern side:-
- (i) from the junction with St Augustine Street south-eastward to the common boundary of Nos. 29/30;
- (ii) from the junction with East Reach north-westward for a distance of 15m;
- (a) On both sides from the junction with Stephen Street north-westward for a distance of 5m;
- (b) On the south-west side from the junction with Priory Avenue south-eastward for a distance of 19m;
- (c) On the north-east side from the junction with Priory Avenue south-eastward for a distance of 5m.

Haydon Road

Gyffarde Street

- (a) On both sides:-
- (i) from the junction with Winchester Street south-eastward to the common

boundary of Nos.16/17;

(ii) from the junction with East Reach north-westward for a distance of 20m;

On both sides:-

- (i) from the junction with Stephen Way north-eastward for a distance of 5m;
- (ii) from the junction with St Augustine Street south-westward to the common boundary of Nos.22/23.
- (a) On both sides:-
- (i) from the junction with Priory Bridge Road south-eastward for a distance of 30m;
- (ii) from the junction with Priory Avenue south-eastward to the common boundary of Nos. 66/68.
- (b) On the south-west side:-
- (i) from the junction with Priory Avenue north-westward to a point opposite the common boundary of Nos. 77/79;
- (ii) from the common boundary of Nos. 52/54 south-eastward to a point 5m south-east of the junction with Stephen Street;
- (iii) from a point 5m north-west of the junction with Laburnum Street south-eastward to a point 5m south-east of that junction;
- (iv) from a point opposite the southern flank wall of No.1 south-eastward for a distance of 17m to the recessed area of carriageway at the side of No. 1 Eastbourne Terrace.
- (c) On the north-east side:-
- (i) from the junction with Priory Avenue north-westward to the southern flank wall of No.77;

Laburnum Street

Stephen Street

Stephen Way

Winchester Street

- (ii) from the southern flank wall of No.1 south-eastward for a distance of 17m.
- (a) On both sides:-
- (i) from the junction with Stephen Way/Priory Court north-eastward to the common boundary of Nos.25/26;
- (ii) from the junction with St Augustine Street south-westward for a distance of 5m;
- (b) On the north-west side from a point 5m south-west of the junction of Gyffarde Street to a point 5m north-east of that junction.
- (a) On both sides from the junction with the Duke Street Flats access road northwestward for a distance of 5m:
- (b) On the south-west side from a point 7m north-west of the entrance to Laburnum Court south-eastward to a point 16m north-west of the Duke Street Flats access road;
- (c) On the north-east side:-
- (i) from the junction with Stephen Street south-eastward for a distance of 5m;
- (ii) from a point 5m north-west of the junction with Laburnum Street south-eastward to a point 5m south-east of that junction.
- (a) On both sides from the common boundary of Nos.1/2 south-eastward to the junction of Hugo Street/Haydon Road;
- (b) On the south-west side:-
- (i) from the junction with Priory Bridge Road south-eastward to the northern flank wall of No.99;
- (ii) from a point 35m north-west of the junction with Priory Avenue south-eastward to a point 22m south-east of that junction;

- (c) On the north-east side:-
- (i) from the junction with Priory Bridge Road south-eastward for a distance of 30m;
- (ii) from the southern flank wall of No.74 south-eastward to a point 18m south-east of the junction with Priory Avenue."
- 4. In Schedule 4 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000, there shall be deleted the following:-

"Eastbourne Gate

On both sides from the junction with Haydon Road eastward for a distance of 15m.

Eastbourne Road

On the east side from a point 15m north of the junction with East Reach northward for a distance of 33m.

Gloucester Street

On both sides from the junction with Haydon Road eastward for a distance of 15m.

Hugo Street

On the north side from a point 20m east of the junction with Winchester Street eastward for a distance of 20m.

Laburnum Street

On both sides from its junction with St Augustine Street south-westward to the common boundaries of Nos.22/23 and 24/25.

Stephen Street

On both sides from the junction with St Augustine Street south-westward for a distance of 5m.

- (a) On the south-west side:-
- (i) from a point opposite the common boundary of Nos.25/27 north-westward to a point opposite the common boundary of Nos.35/37;
- (ii) from a point opposite the common boundary of Nos.51/53 north-westward to a point opposite the common boundary of Nos.61/63;

(iii) from a point 30m south-east of the junction with Priory Bridge Road south eastward for a distance of 16m;

(b) On the north-east side from the eastern boundary of No.77 north-westward to a point 30m south-east of the junction with Priory Bridge Road.

Winchester Street

On the north-east side from a point 30m south-east of the junction with Priory Bridge Road south-eastward to the common boundary of Nos. 74/76."

5. In Schedule 4 to The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000, there shall be inserted the following:-

"Eastbourne Road

On the eastern side from a point 15m north-west of the junction with East Reach north-westward to the southern flank wall of the No.49.

Gloucester Street

On both sides from the junction with Haydon Road north-eastward to the common boundary of Nos. 15/16.

Gyffarde Street

On the south-west side from a point 10m south-east of the junction with Priory Avenue south-eastward for a distance of 9m:

St Augustine Street

- (a) On the south-west side from a point 30m south-east of the junction with Priory Bridge Road south-eastward to the northern flank wall of No.108;
- (b) On the north-east side from the common boundary of Nos. 95/97 south-eastward to the common boundary of Nos. 91/93".
- 6. In Schedule 9 to The Taunton Deane Borough (Prohibition and Restriction of Waiting) (Loading and Unloading) (Various Streets in Taunton) Order, 2000, there shall be deleted the following:-

"Eastbourne Road

On the eastern side from a point 48m north of the junction with East Reach northwards to the common boundary of Nos. 31/32.

St Augustine Street

- (a) On the south-west side:-
- (i) from a point opposite the common boundary of Nos. 3/5 north-westward to a point opposite the common boundary of Nos. 25/27;
- (ii) from a point opposite the common boundary of Nos. 35/37 north-westward to a point opposite the common boundary of Nos. 51/53;
- (iii) from a point opposite the common boundary of Nos. 61/63 north-westward to the common boundary of Nos. 66/68'
- (iv) from a point opposite the common boundary of Nos. 77/79 north-westward to a point 46m south-west of the junction with Priory Bridge Road;
- (b) On the north-eastern side from a point 27m south-eastward of the common boundary of Nos. 3/5 south-eastward to the end of the recessed area of carriageway at the side of No. 1 Eastbourne Terrace".
- 7. In Schedule 9 of The Taunton Deane Borough (Prohibition and Restriction of Waiting, Loading and Unloading) (Various Streets in Taunton) Order, 2000, there shall be inserted the following:-

"Eastbourne Road

- (a) On the western side from the common boundary of Nos. 9/10 south-eastward to a point 20m north-west of the junction with East Reach;
- (b) On the eastern side from the common boundary of Nos. 46/47 south-eastward to the southern flank wall of No. 49.

Gyffarde Street

On the north-east side from the southern flank wall of No. 7 south-eastward to a point 5m north-west of the junction with Stephen Street.

- (a) On the south-west side:-
- (i) from the common boundary of Nos 66/68 south-eastward to the common boundary of Nos. 52/54;
- (ii) from a point 5m south-east of the

junction with Laburnum Street southeastward to a point opposite the southern flank wall of No. 1;

(b) On the north-east side from a point 17m south-east of the southern flank wall of No. 1 south-eastward and then around the recessed area of carriageway at the side of No. 1 Eastbourne Terrace.

Winchester Street

On the south-west side from the common boundary of Nos. 89/91 south-eastward to the common boundary of Nos. 85/87".

8. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any Regulation made or having effect as if made under the Act or by or under any other enactment.
