

THE TAUNTON DEANE BOROUGH (OFF-STREET PARKING PLACES)
(NO. 29 AMENDMENT) ORDER 2006

The Taunton Deane Borough Council in exercise of their powers under Section 35 (1) of the Road Traffic Regulation Act, 1984 ("the Act"), and of all other enabling powers, with the consent of the Somerset County Council, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

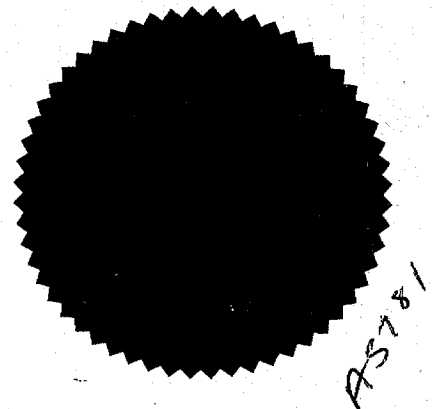
