THE TAUNTON DEANE BOROUGH (PART OF THE ST AUGUSTINE AREA, TAUNTON) (DESIGNATED PARKING PLACES) (NO.3 AMENDMENT) ORDER 2004

The Taunton Deane Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Somerset in exercise of the powers of the said County Council under Sections 1 (1), 2 (1) and (2), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984 ("the Act"), hereby makes the following Order:-

- 1. This Order shall come into operation on 5 July 2004 and may be cited as "The Taunton Deane Borough (Part of The St Augustine Area, Taunton) (Designated Parking Places) (No. 3 Amendment) Order 2004."
- 2. In Schedule 1 (Permit Parking 8.00 am to 6.00 pm Monday to Saturday) to The Taunton Deane Borough (Part of the St Augustine Area, Taunton) (Designated Parking Places) Order 2001, there shall be <u>inserted</u> the following:-
