TELFORD & WREKIN COUNCIL (DAWLEY HIGH STREET, BURTON STREET AND GEORGE STREET) (PROHIBITION OF MOTOR VEHICLES) ORDER 2016

Borough of Telford & Wrekin (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4, the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following order.

- This order shall come into operation on 18 November 2016 and may be cited as Telford and Wrekin Council (Dawley High Street, Burton Street and George Street) (Prohibition of Motor Vehicles) Order 2016.
- 2. The Order referred to in Schedule One to this Order is hereby revoked to the extent detailed therein.
- 3. (1) In this Order:-

"Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984. Each area of a highway comprising, unless otherwise described, a length of carriageway of a highway bounded on one side by the edge of the carriageway and having a width throughout of 1.8 or 2.0 metres, is authorised as a parking place.

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges For Motor Vehicles) Regulations 2000.

"Disabled Persons Vehicle" has the same meaning as defined in the Act which is a Vehicle lawfully displaying a Disabled Persons Badge

"Parking Disc" means a disc issued by a local authority, 125 millimetres square and coloured blue, capable of showing the quarter hour period during which a period of waiting begins.

"Parking Place" means a length of road indicated by traffic signs authorised to be used by Vehicles in accordance with the provisions of this Order.

"Vehicle" means any motor Vehicle or trailer as defined in the Act and includes a machine or implement of any kind drawn or propelled along road whether by animal or mechanical power

- (2) For the purpose of this Order a Vehicle shall be regarded as displaying:-
 - (a) a Disabled Person's Badge in the relevant position, when:-
 - (i) in the case of a Vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a Vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the Vehicle, and

- (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. Save as provided in Article 6 to this Order no person shall except upon the direction of or with the permission of a police constable in uniform, cause or permit any Vehicle to wait load or unload at any time on any day on the sides of the roads specified in Column 1 Schedule Two and along the lengths of those roads described in Column 2 Schedule Two to this Order.
- 6. Nothing in Articles 5, 8, 11 and shall render it unlawful to cause or permit any Vehicle to wait on the sides of lengths of roads referred to therein for so long as may be necessary to enable:-
 - (a) persons to board or alight from a Vehicle:
 - (b) the Vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - (c) a Vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) a Vehicle, to be used for the purpose of delivering or collecting postal packets as defined by the Postal Services Act 2000:
 - (e) a Vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
 - (f) the Vehicle to be used for Fire Brigade, Ambulance or Police purposes
- 7. Nothing in Article 5 to this Order shall render it unlawful to cause or permit any Vehicle to wait upon an Authorised Parking Place.

- 8. Save as provided in Article 6 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle to park, stop or wait between the hours of 8.00am 6.00pm on Monday to Saturday in an Authorised Parking Place on the sides of the roads specified in Column 1 Schedule Three and along the lengths of those roads described in Column 2 Schedule Three of this Order.
 - (a) For a longer period than 20 minutes; or
 - (b) If a period of less than one hour has elapsed since the termination of the last period of waiting by that Vehicle.
- 9. The driver of a Vehicle using a Parking Place shall stop the engine as soon as the Vehicle is in position in the Parking Place, and shall not start the engine except when about to change the position of the Vehicle in or to depart from the Parking Place.
- 10. No person shall use a Vehicle while it is in a Parking Place, in connection with the sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of his skills or services.
- 11. Save as provided in Article 6 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle to park, stop or wait at any time on the sides of the roads specified in Column 1 Schedule Four and along the lengths of those roads described in Column 2 Schedule Four of this Order unless Displaying a valid Disabled Person's Badge and Parking Disc.
- 12. No person shall except under direction or with the permission of a police constable in uniform, cause or permit any Vehicle to be driven on the roads specified in Column 1 Schedule Five except in the direction specified in Column 2 Schedule Five to this Order.
- 13. No person shall cause or permit any Vehicle to proceed in the roads specified in Column 1 Schedule Six and along the lengths of the roads specified in Column 2 Schedule Six on any Friday between the hours of 8.00am and 4.00pm.
- 14. The restrictions specified in Schedule 8, 11 and 12 are suspended on the day of the week and between the times of the day specified in Schedule Six.
- 15. Nothing in Article 13 of this Order shall apply if the Vehicle being used is
 - (i) specifically authorised by the Council
 - (ii) requires access to off-street parking areas in Burton Street and George Street
 - (iii) being used in the service of a local authority or any other body in the pursuance of statutory powers or duties and cannot conveniently be used for such purpose in any other road
 - (iv) Is being used for fire and rescue service, ambulance or police purposes.

17. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, the provision of this Order shall prevail during the times Vehicles are prohibited from driving pursuant to this Order.
