

TELFORD & WREKIN COUNCIL
(VARIOUS ROADS, NEWPORT & CHURCH ASTON) (PROHIBITION OF
WAITING, RESTRICTION OF WAITING AND RESTRICTION OF STOPPING)
ORDER 2013

BOROUGH OF TELFORD AND WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on Friday 9th August 2013, and may be cited as the Telford & Wrekin Council (Various Roads, Newport & Church Aston) (Prohibition of Waiting, Restriction of Waiting and Restriction of Stopping) Order 2013.
2. (1) In this Order:-

"Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges For Motor Vehicles) Regulations 2000.

"Parking Disc" means a disc issued by a local authority, 125 millimetres square and coloured blue, and capable of showing the quarter hour period during which a period of waiting begins.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) a Disabled Person's Badge in the relevant position, when:-
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- (3) except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. Save as provided in Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the lengths of roads specified in Schedule One of this Order.
4. Save as provided in Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle

to wait between the hours of 8.00am – 9.30am and 2.30pm - 4.00p.m, on Monday to Friday on the roads specified in Schedule Two of this Order.

5. (1) Nothing in Articles 3 or 4 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads referred to therein for so long as may be necessary to enable:-
 - (a) persons to board or alight from a vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
 - (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 3 or 4 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in the Schedule to this Order, at any time.
- (3) Nothing in Article 3 or 4 to this Order shall render it unlawful to cause or permit any vehicle:
 - (a) to wait upon an Authorised Parking Place

- (4) Nothing in Article 3 or 4 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
6. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop between the hours of 8.00am and 5.00pm, Monday to Friday on of the roads specified in Schedule Three of this Order.
7. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.


Schedule One - (Prohibition of Waiting)	
Column 1	Column 2
Audley Avenue, Newport (South west side)	From a point approximately 71m north west of the centreline of Granville Avenue for a distance of approximately 119m in a south easterly direction.
Audley Avenue, Newport (North east side)	From a point approximately 71m north west of the centreline of Granville Avenue for a distance of 167m in a south easterly direction.
Avenue Road, Newport (South side)	From its junction with Upper Bar to a point approximately 27m east of the centreline of Avenue Road South.
Avenue Road, Newport (North side)	From its junction with Upper Bar for a distance of approximately 63m in a easterly direction.
Avenue Road South, Newport (Both sides)	From its junction with Granville Avenue for a distance of approximately 15m in a north westerly direction. From its junction with Avenue Road for a distance of approximately 15m in a south easterly direction.
Boughey Road, Newport (North side)	From its junction with Wellington Road to its junction with Ellesmere Court.
Boughey Road, Newport (South side)	From its junction with Wellington Road for a distance of approximately 18m in a westerly direction.
Granville Avenue, Newport (Both Sides)	From its junction with Audley Avenue for a distance of approximately 26m in a southerly direction. From a point approximately 16m north of the centreline of Avenue Road South for a distance of approximately 43m in a southerly direction.
Granville Avenue, Newport (North west side)	From its junction with Station Road to a point approximately 74m north east of the centreline of Granville Close.

Granville Avenue, Newport (South east side)	From its junction with Station Road for a distance of approximately 42m in a north easterly direction.
Granville Close, Newport (East side)	From its junction with Granville Avenue for a distance of approximately 40m in a generally northerly direction.
Granville Close, Newport (West side)	From its junction with Granville Avenue for a distance of approximately 23m in a northerly direction.
Granville Road, Newport (Both sides)	From its junction with Station Road for a distance of approximately 21m in a westerly direction.
Granville Road, Newport (North side)	From its junction with Wellington Road for a distance of approximately 48m in a easterly direction.
Granville Road, Newport (South Side)	From its junction with Wellington Road for a distance of approximately 19m in a easterly direction.
Upper Bar, Newport (East side)	From its junction with Avenue Road to its junction with Granville Avenue.
Upper Bar, Newport (West side)	From its junction with Wellington Road to its junction with Granville Road.
Wellington Road, Newport (North west side)	From its junction with High Street for a distance of approximately 207m in a generally south westerly direction. From a point approximately 36m south west of the centreline of Boughey Road for a distance of approximately 74m in a north easterly direction.
Wellington Road, Newport (South east side)	From its junction with High Street for a distance of approximately 127m in a generally south westerly direction. From a point approximately 154m south west of its junction with High Street for a distance of approximately 23m in a south westerly direction. From a point approximately 33m south west of the centreline of Granville Road for a distance of approximately 109m in a north easterly direction.
Station Road, Newport (North east side)	From its junction with Granville Avenue to a point approximately 65m south east of the centreline of Granville Avenue.
Station Road, Newport (South west side)	From its junction with Granville Road to a point approximately 34m south east of the centreline of Granville Road.
Schedule Two (Restriction of Waiting) Monday to Friday - 8am-9.30am and 2.30pm-4pm	
Column 1	Column 2
Granville Avenue, Newport (West side)	From a point approximately 26m south of its junction with Audley Avenue for a distance of approximately 38m in a southerly direction. From a point approximately 26m south of its junction with Avenue Road South for a distance of approximately 125m in a southerly direction.
Avenue Road, Newport (North side)	From a point approximately 13m west of the centreline of Avenue Road South for a distance of approximately 41m in a easterly direction.

Schedule Three (Restriction of Stopping) Monday to Friday – 8am to 5pm	
Column 1	Column 2
Audley Avenue, Newport (South East Side)	From a point approximately 153m east of the centreline of Granville Avenue for a distance of approximately 70m in a easterly direction.
Greenvale, Church Aston (North Side)	From a point approximately 61m west of the centreline of The Spinney for a distance of approximately 31m in a westerly direction.
Wellington Road, Newport (North East Side)	From a point approximately 14m north east of the centreline of Brookside Avenue for a distance of approximately 44m in a north easterly direction.
	From a point approximately 102m north east of the centreline of Brookside Avenue for a distance of approximately 25m in a north easterly direction.
Avenue Road, Newport (South Side)	From a point approximately 119m west of its junction with Upper Bar for a distance of approximately 70m in a westerly direction.
Granville Avenue, Newport (North Side)	From a point approximately 117m north east of its junction with Station Road for a distance of approximately 43m in a north easterly direction.
