

**TELFORD & WREKIN COUNCIL**  
**(VARIOUS ROADS, WELLINGTON AND APLEY) (PROHIBITION OF WAITING,**  
**PROHIBITION OF WAITING AND LOADING, ON STREET PARKING PLACES &**  
**LOADING BAY) ORDER 2016**

BOROUGH OF TELFORD & WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

1. This Order shall come into operation on 14 October 2016, and may be cited as the Telford & Wrekin Council (Various Roads, Wellington and Apley) (Prohibition of Waiting, Prohibition of Waiting and Loading, On Street Parking Places and Loading Bay) Order 2016.
  2. The Orders specified in Schedule 1 of this Order shall cease to have effect.
  3. The Orders specified in Column 1 of Schedule 2 will be varied to remove the restrictions on the roads specified in Column 2 of Schedule 2 to the extents specified in Column 3 of Schedule 2.
  4. (1) In this Order:-

"Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 2000.

"Parking Disc" means a disc issued by a local authority, 125 millimetres square and coloured blue, capable of showing the quarter hour period during which a period of waiting begins.
  - (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
    - (a) a Disabled Person's Badge in the relevant position, when:-
      - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
      - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
    - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
  - (3) except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
5. Save as provided in Article 10 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the roads specified in Schedule 3 of this order.

6. Save as provided in Article 10 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time nor load at any time on the roads specified in Schedule 4 of this order.
7. Save as provided in Article 10 or this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8.00am – 6.00pm on Monday to Saturday on the roads specified in Schedule 5 of this Order.
  - (a) For a period of longer than 30 minutes; or
  - (b) If a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle.
8. Save as provided in Article 10 or this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 8.00am – 6.00pm on Monday to Saturday on the roads specified in Schedule 6 of this Order.
  - (a) For a period of longer than 2 hours; or
  - (b) If a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle.
9. Save as provided in Article 10 or this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to load and unload between the hours of 8.00am – 6.00pm on Monday to Saturday on the roads specified in Schedule 7 of this Order.
  - (a) For a period of longer than 40 minutes; and
10. (1) Nothing in Articles 5, 6, 7, 8 & 9 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads referred to therein for so long as may be necessary to enable:-
  - (a) persons to board or alight from a vehicle;
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
    - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
  - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
  - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
  - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or

- (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
  - (2) Nothing in Article 5 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in Schedule 3 to this Order, at any time.
  - (3) Nothing in Article 5, 6, 7, 8 & 9 to this Order shall render it unlawful to cause or permit any vehicle to wait upon an Authorised Parking Place
  - (4) Nothing in Article 5, 7 & 8 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
11. The driver of a vehicle using a parking place of the type in Articles 7, 8 & 9 shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
  12. No person shall use a vehicle while it is in a parking place of the type in Articles 7, 8 & 9, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills or services.
  13. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

(i) Church Street (East Side)	From the junction with Vineyard Road in a southerly direction for 233m turning into Station Road for 11m
(ii) Stonechat Close (Both), Kingfisher Way (Both)	From the junction with Grainger Drive for a distance of 62m in a south easterly direction. From the junction with Kingfisher Way for a distance of 36m in a westerly direction.
(iii) Hordley Road (North Side)	From the junction with Bagley Drive for a distance of 21m in a north westerly direction
	From a point 59m from the junction with Bagley Drive for 30m in a north westerly direction
(iv) King Street Layby (East Side)	From a point 26m south of Plough Road for 33m on the east side of the parking layby
(v) Glebe Street (Both Sides)	From the junction with Victoria Road for 71m in south easterly direction
	From the junction with Glebe Street for 10m in a south westerly direction into Glebe Street (cul de sac)
(vi) Albert Road (North Side)	From a point 31m from King Street for 15m in an easterly direction
(vii) Wrekin Road (East Side)	From a point 14m north of Roseway for 89m in a southerly direction
(viii) Wrekin Road (West Side), Roseway (South Side)	From a point 70m south of Roseway on Wrekin Road in a northerly direction turning into Roseway for 14m

(iii) Church Street (East Side)	From the junction with Station Road in a southerly direction for 18m turning to Market Street in an easterly direction for 10m

(i) Hordley Road (North Side)	From 21m from the junction with Bagley Drive for a distance of 38m in a north westerly direction
(ii) Bagley Drive (North Side - layby)	From the junction with Hordley Road for a distance of 37m in a north easterly direction

<b>Schedule 6 - (On Street Parking Place) 2 hours No Return Within 1 hour</b>

(i) King Street Layby (West Side)	From a point 8m south of Plough Road for 74m on the west side of the parking layby

<b>Schedule 7 - (Restricted Loading) 40 mins</b>

(i) Rowland Gate (North Side)	From a point 60m east of junction with Bridge Road for a distance of 16m in a easterly direction
