

**TELFORD & WREKIN COUNCIL (VARIOUS ROADS, HOLLINSWOOD, TELFORD)  
(PROHIBITION OF WAITING) ORDER 2020**

BOROUGH OF TELFORD & WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

1. This Order shall come into operation on 6<sup>th</sup> March 2020, and may be cited as the Telford & Wrekin Council (Various Roads, Hollinswood, Telford) (Prohibition of Waiting) Order 2020.
  
  2. (1) In this Order:-
    - "Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;
  
    - "Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 2000.
  
    - "Parking Disc" means a disc issued by a local authority, capable of showing the quarter hour period during which a period of waiting begins.
  
  - (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
    - (a) A Disabled Person's Badge in the relevant position, when:-
      - (i) In the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
  
      - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
  
    - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
  
  - (3) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 
3. (1) Nothing in Article 5 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads specified in the Schedule to this order for so long as may be necessary to enable:-
  - (a) persons to board or alight from a vehicle;
  
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) building, industrial or demolition operations;

- (ii) the removal of any obstruction to traffic;
  - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
  - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
- (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
  - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
  - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
  - (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 5 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in the Schedule to this Order, at any time.
  - (3) Nothing in Article 5 to this Order shall render it unlawful to cause or permit any vehicle:
    - (a) to wait upon an Authorised Parking Place
  - (4) Nothing in Article 5 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment
5. Save as provided in Article 3 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the lengths of roads specified in Schedule to this Order

**Schedule (No waiting at any time)**

1. Dale Acre Way, Hollinswood (the south side) from a point 37m east of the centreline of Deepdale in a westerly direction to a point 2m east of the centreline of Downmead
2. Dallamoor, Hollinswood (both sides) from a point 10m from its junction with Dallamoor for a distance of 26m in a north easterly direction
3. Dallamoor, Hollinswood (the north side) from its junction with Dale Acre Way for a distance of 83m in a westerly direction
4. Dallamoor, Hollinswood (the south side) from its junction with Dale Acre Way for a distance of 84m in a westerly direction
5. Darliston, Hollinswood (both sides) from its junction with Dale Acre Way for a distance of 15m in a southerly direction
6. Deepdale, Hollinswood (both sides) from a point 12m from its junction with Dale Acre Way for a distance of 53m in a northerly direction
7. Downmead, Hollinswood (the east side) from a point 50m south of its junction with Dale Acre Way in a southerly direction for a distance of 99m
8. Downmead, Hollinswood (the west side) from a point 58m south of its junction with Dale Acre Way for a distance of 76m, in a southerly direction
9. Downmead, Hollinswood (the west side) from a point 13m south of its junction with Dale Acre Way in a southerly direction for a distance of 45m
10. Dudmaston, Hollinswood (the east side) from a point 9m into Dudmaston (side road) for a distance 68m in a southerly direction
11. Dudmaston, Hollinswood (the north side) from its junction with Dale Acre Way for a distance of 29m in an easterly direction
12. Dudmaston, Hollinswood (the west side) from its junction with Dale Acre Way for a distance of 80m in an southerly direction
13. Dunsheath, Hollinswood (the north side) from its junction with Dunsheath for a distance of 90m in an easterly direction
14. Dunsheath, Hollinswood (the south side) from a point 23m from its junction with Dale Acre Way for a distance of 79m in an easterly direction
