THE BOROUGH COUNCIL OF TEST VALLEY ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF TEST VALLEY (BLACK SWAN YARD, GEORGE YARD AND UPPER HIGH STREET, ANDOVER) (PEDESTRIAN ZONE) ORDER 2010

The Borough Council of Test Valley, as agent for Hampshire County Council in exercise of its powers under Sections 1, 2 and 3(2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, Part IV of Schedule 9 to the Act, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- Save as provided in Article 2 of this Order, no person shall cause any vehicle to proceed wait or load/unload at any time in the entire area of roads specified in the Schedule to this Order and shown solid green on the attached drawing S/34/2/2/66 REV A.
- 2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in George Yard if the vehicle is being used to gain access to and egress from private land shown hatched green on the attached drawing S/34/2/2/66 REV A.
- 3. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to proceed wait or load/unload at any time in that part of High Street Andover shown solid green and marked "High Street" on the attached drawing S/34/2/2/66 REV A if the vehicle is being used for fire and rescue service, ambulance or police purposes.
- 4. The Borough of Test Valley (High Street Andover) (Prohibition of Driving and Cycling)
 Order 1989 and The Test Valley Borough Council (Various Roads, Andover) (Prohibition
 and Restriction of Waiting) (No 2)) Order 1977 are hereby revoked in so far as they
 relate to the lengths of roads specified in the Schedule to this Order.
- 6. This order shall come into operation on the 29 October 2010 and may be cited as "The Borough of Test Valley (Black Swan Yard, George Yard and Upper High Street, Andover) (Pedestrian Zone) Order 2010".
