



Anton Area Parking Restrictions



ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF TEST VALLEY (PARKING PLACES AND RESTRICTION OF WAITING) (ANDOVER) VARIATION ORDER 2012

The Borough Council of Test Valley as agent for Hampshire County Council (being the Traffic Authority) in exercise of its powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

I. VARIATION OF ORDERS

- 1. In this order
 - a)"the 2003 Order" means The Hampshire (Various Roads, Andover) (Parking Places and Restriction of Waiting) Order 2003,
 - b)" the 2009 Station Zone Order" means The Borough of Test Valley (Station Zone, Andover) (Parking Places and Restriction of Waiting and Stopping) (Controlled Zone) Order 2009, and
 - c)"the 2008 Order" means The Borough of Test Valley (Anton Area, Andover) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2008
 - d)"the 2009 Order" means The Borough of Test Valley (Various Roads, Andover) (Parking Places and Restriction of Waiting) (Station Area) Order 2009)
- 2. The 2003 Order shall have effect as though the lengths of Colebrook Way Andover with no waiting as set out in Schedule 1a hereto were deleted therein and the lengths of Colebrook way with no waiting at any time as set out in Schedule 1b hereto were included therein.
- 3. The 2008 Order shall have effect as though the drawing numbers referred to as set out in Column 2 of Schedule 2a hereto were deleted and the drawing numbers as set out in Column 2 of Schedule 2b hereto were included therein.
- 4. The 2009 Order shall have effect as though the drawing numbers referred to as set out in Column 2 of Schedule 3a hereto were deleted and the drawing numbers as set out in Column 2 of Schedule 3b hereto were included therein.
- 5. The 2009 Order shall have effect as though the lengths of roads with no waiting as set out in Schedule 4a hereto were deleted and the lengths of roads with no waiting as set out in Schedule 4b hereto were included therein.

- 6. The 2009 Station Zone Order shall have effect as though the drawing numbers referred to as set out in Column 2 of Schedule 5a hereto were deleted and the drawing numbers as set out in Column 2 of Schedule 5b hereto were included therein.
- 7. The 2009 Station Zone Order shall have effect as though the parking places as set out in Schedule 6 hereto were deleted therein and the parking places as set out in Schedule 7 hereto were included therein.
- 8. The 2009 Station Zone Order shall have effect as though the lengths of roads with no waiting at any time as set out in Schedule 8a hereto were deleted and the lengths of roads with no waiting at any time as set out in Schedule 8b hereto were included therein.
- 9. The 2009 Station Zone Order shall have effect as though the lengths of roads with no waiting as set out in Schedule 9a hereto were deleted and the lengths of roads with no waiting as set out in Schedule 9b hereto were included therein.

II. NEW RESTRICTION OF WAITING

- 10. Save as provided in articles 11 and 12 of this order, no person shall, except upon the direction or with the permission of a police constable in uniform or civil enforcement officer, cause or permit any vehicle to wait:-
 - at any time on the sides of road specified in schedule 10 to this order;
 - (ii) between the hours of 10.00am and 3.00pm from Monday to Saturday (both days inclusive) on the sides of road specified in schedule 11 to this order.
- 11. Nothing in article 10 of this order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road referred to in that article for so long as may be necessary:-
 - a. to enable a person to board or alight from the vehicle;
 - b. to enable goods to be loaded onto or unloaded from the vehicle:
 - c. to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with the following operations namely:
 - i. the removal of any obstruction to traffic;

- ii. the maintenance, improvement or reconstruction of the said sides of road:
- iii. the laying, erection, alteration or repair in, or in land adjacent to, the said sides of road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or telecommunications;
- d. to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
- to enable the vehicle to be used in the service of the Post Office for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
- f. to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said sides of road;
- g. to enable the vehicle to wait at or near to any premises situated on or adjacent to the said sides of road for so long as is reasonably necessary in connection with any wedding or funeral; or
- h. to enable the vehicle to be used for fire and rescue service, ambulance or police purposes.
- 12. Nothing in article 32 of this order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on any of the sides of road referred to for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road on the same day).
- 13. This Order shall come into operation on the 4th April 2012 and may be cited as "The Borough of Test Valley (Parking Places and Restriction of Waiting) (Andover) Variation Order 2012".
