
ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF TEST VALLEY (CRICKETERS WAY / RIVER WAY ARCH, ANDOVER) (PROHIBITION OF DRIVING) ORDER 2015

The Borough Council of Test Valley as agent of Hampshire County Council (being the Traffic Authority) in exercise of its powers under Sections 1, 2, and 3 of the Road Traffic Regulation Act 1984 ("the Act") as amended, Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

- 1. In this order and the preamble and schedule hereto:
 - "the Act" means the Road Traffic Regulation Act 1984;
 - "pedal cycle" means a unicycle, bicycle, tricycle, or a cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act;
 - "local bus" means local bus services registered under the 1985 Transport Act; and
 - "road" means any length of highway or any other length of road to which the public has access, and includes bridges over which a road passes.
- No person shall cause any vehicle to proceed in that length of road between Cricketers Way and River Way as shown delineated and edged red on the plan attached hereto.
- 3. Nothing in article 2 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the length of road referred to in that article if the vehicle is:
 - (a) a local bus;
 - (b) a pedal cycle which is not a motor vehicle:
 - (c) being used in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or





adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water, electricity or telecommunications; or

- (d) police, ambulance, local authority or fire and rescue service purposes.
- 4. The Borough of Test Valley (Cricketers Way/River Way Arch, Andover) (One Way Bus Route) Order 2011 is hereby revoked.
- This order shall come into operation on the 1st November 2015 and may be cited as "The Borough of Test Valley (Cricketers Way / River Way Arch, Andover) (Prohibition of Driving) Order 2015".
