

**THE BOROUGH COUNCIL OF TEST VALLEY  
OFF STREET PARKING PLACES ORDER 2016**

The Borough Council of Test Valley in exercise of the powers conferred upon them by the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended by the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hampshire) (Borough of Test Valley) Order 2003 and also in exercise of the powers conferred upon them by The Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, with the consent of Hampshire County Council in accordance with Section 39(3) of the 1984 Act and after consulting with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 to the 1984 Act, hereby make the following Order:-

**PART I**

**COMMENCEMENT AND CITATION**

1. This Order shall come into force on the first day of April 2016 and shall be cited as "The Borough Council of Test Valley Off Street Parking Places Order 2016".
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Borough Council of Test Valley Off Street Parking Places, (No 2) (Amendment ) Order 2015 is hereby revoked.
3. Any reference in this Order to a numbered Article or to a numbered Schedule is a reference to the Article or to the Schedule bearing that number in this Order.
4. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
  - "bus" – means a public service vehicle as defined by Section 1 of the Public Passenger Vehicles Act 1981.
  - "charging hours" – means the time or times stipulated in column 2 of Schedules 3 to 5 inclusive during which a motor vehicle shall not be left in a parking place unless the correct parking charge is paid or a parking pass is displayed in the relevant position.

"civil enforcement officer" - means any person who has become or who is appointed as such by the Council under the provisions of section 76 of the 2004 Act.

"coach parking bay" - means any area within a parking place that is provided for the leaving of a single coach and which is indicated by markings on the surface of the parking place or signed or otherwise indicated by signs or any other structure whatsoever placed or erected in the parking place.

"coach" - means a chartered long distance single or double-decker bus constructed to carry more than eight seated passengers in addition to the driver.

"Council" - means The Borough Council of Test Valley.

"disabled persons' badge" - shall have the meaning assigned to it by section 2(1) of the Disabled Persons (Badges for Motor vehicles) (England) Regulations 2000.

"disabled persons motor vehicle" – means a motor vehicle upon which there is displayed a disabled persons badge.

"driver" - shall have the meaning assigned to it by section 142(1) of the 1984 Act.

"loading area" shall have the meaning assigned to it by Section 61(1)(a) of the 1984 Act.

"market day" - means between 00:01 hours and 18:00 hours on every Thursday and Saturday or between those same hours on any other day when the Council by notice suspends the use of the parking place specified within the said notice to enable a market to take place as set out in The Test Valley Borough Council Market Regulations from time to time in force.

"market trader" - means a person occupying and trading from a pitch on the market in High Street, Andover on a market day.

"market traders motor vehicle" - means a motor vehicle constructed or adapted and used solely for the conveyance of goods with or without a trailer attached the combined gross weight of which does not exceed 7500 kilograms the owner or driver of which is a market trader.

“motor vehicle” - means a mechanically propelled vehicle of any description that is intended or adapted for use on a highway, whether or not it is in a fit state for such use and includes any chassis or body with or without wheels appearing to have formed part of such a motor vehicle and anything attached to such a motor vehicle.

“motorcycle bay” - means any area within a parking place that is indicated by markings on the surface of the parking place or otherwise indicated by signs or any other structure whatsoever placed or erected in the parking place that is provided for the leaving of one or more solo motorcycles.

“owner” - shall have the meaning assigned to it in section 92 of the 2004 Act.

“parking attendant” - means any person who is appointed by the Council as such under the provisions of section 63A of the 1984 Act.

“parking bay” - means any area within a parking place that is provided for the leaving of a single PLG motor vehicle and which is indicated by markings on the surface of the parking place or otherwise indicated by signs or any other structure whatsoever placed or erected in the parking place.

“parking charge” - means the parking charges stipulated in Schedules 1 and 2 to be paid for the parking of motor vehicles left in a parking place.

“parking contravention” shall have the meaning assigned to it in section 93 of the 2004 Act.

“parking device” - means either a ticket, card, disc, token, meter, parking meter (which shall have the meaning assigned to it by section 46(2)(a) of the 1984 Act) permit, stamp or other similar device and any electronic cash or cashless apparatus or device whether used in a vehicle or not and which being used either by itself or in conjunction with any other apparatus such as a computer device, smart phone or touch tone cellular telephone, debit card, credit card or prepaid card system and which indicates or causes to be indicated the payment of any parking charge and the period in respect of which any parking charge has been paid and the time of the beginning or end of the period.



"parking pass" - means a valid:

- (i) season ticket,
- (ii) Council member's permit,
- (iv) residents permit,
- (v) visitors permit,
- (vi) Andover Shopmobility permit,
- (vii) Council staff permit (issued to an officer of the Council),
- (viii) Romsey Rapids staff permit (issued to an employee of Romsey Rapids),
- (ix) High Street, Andover permit; or,
- (x) any other parking permit permitting a motor vehicle to be left in a stated parking place on such terms and conditions as the Council shall decide,

in each case issued by the Council.

"parking place" or "parking places" - means any of the places (or parts of parking places) referred to by number and name in the first column of Schedules 3 to 5 which said parking places are identified by grey colouring and edged with a heavy black line and with the said number endorsed within a circle either upon or adjacent to such parking place on either of the two maps attached to this Order.

"parking ticket" - means a ticket purchased from a parking ticket dispensing machine indicating the payment of a parking charge and the period in respect of which that parking charge has been paid for parking in the parking place named upon it.

"PCN" - means a penalty charge notice.

"penalty charge" - shall have the meaning assigned to it in section 92 the 2004 Act

"penalty charge notice" - shall have the meaning assigned to it in section 92 the 2004 Act.



“PLG motor vehicle” - means any motor vehicle that is either a motor car or a light goods vehicle with or without a trailer attached or solo motorcycle or motorcycle with sidecar attached, the combined unladen weight of which PLG motor vehicle does not exceed 2524 kg.

“relevant position” – means:

- (1) in connection with the display upon a motor vehicle of a parking ticket or parking pass:-
  - (i) if the motor vehicle is fitted with a front windscreen the parking ticket or parking pass shall be displayed immediately behind the windscreen either attached to it or upon the dashboard or fascia so that the parking ticket is readable from the outside of the motor vehicle; or,
  - (ii) in the case of a motor vehicle not fitted with a front windscreen or dashboard or fascia the parking ticket or parking pass shall be exhibited in a conspicuous and readable position on the motor vehicle.
- (2) in connection with the display upon a motor vehicle of a disabled persons badge or parking disc means the position defined in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000.

“season” – means any period of one or more consecutive calendar months such period to be determined by the Council.

“solo motorcycle” - means a mechanically propelled vehicle not being an invalid carriage having only two wheels and not having a side car or trailer attached thereto of which the weight unladen does not exceed 410 kilograms.

“trailer” – means a vehicle drawn by a motor vehicle and any trailer shall be deemed to be a separate vehicle.

5. Any reference in this Order to an enactment includes reference to that enactment as amended or replaced from time to time and to any subordinate legislation or byelaw made under that enactment.

**PART II**  
**PROVISION OF OFF STREET PARKING PLACES**

6. The Council in pursuance of the power conferred upon it by section 32(1)(a) of the 1984 Act hereby provides the parking places.

**PART III**  
**USE OF PARKING PLACES**

7. Each parking place may, subject to the provisions contained in this Order, be used as a parking place on the days and during the times of availability for parking specified in column 3 for the classes of motor vehicles specified in column 4 for the maximum waiting period specified in column 5 of Schedules 3 to 5.
8. Pedestrian access within a parking place is available only to persons driving or being conveyed in motor vehicles and entering the parking place solely for the purpose of or in connection with the parking of a motor vehicle and does not extend to pedestrians other than the drivers of motor vehicles or their passengers leaving or returning to their motor vehicles and no right of way whatsoever over the parking place other than for the purpose of parking or removing motor vehicles shall be deemed to have been granted by the Council.
9. If owing to the presence of a vehicle in a parking place an accident occurs whereby personal injury or damage is caused to any property (including the parking place) or to any vehicle, the driver of the motor vehicle shall stop and if required by any officer agent or servant of the Council or any other person having reasonable grounds for so requiring shall give his or her name and address and also the name and address of the owner and the identification marks of the motor vehicle and details of his or her certificate of insurance and further the driver shall by the next working day report the incident to the Council.
10. The Council may at its own discretion alter the layout of any parking place by:
- 10.1. reducing or increasing the numbers of parking bays or by changing the route of the access ways or roads within the parking place; or,
  - 10.2. changing the ratio of parking between PLG motor vehicles and coaches and solo motorcycles and disabled persons motor vehicles.



11. The Council may following 21 days public notice provide security devices at any parking place including (but not by limitation) lighting, walls, fencing, bollards, gates or barriers and may for any reason, for example to prevent nuisance either within the parking place or to adjoining properties, lock the gates or barriers on the days and at the time or times stated upon a notice erected at the entrances and exits of such parking place and the use of that parking place shall be considered to be suspended during the times that the gates or barriers are locked for the purposes of this Order.
12. The Council may without notice provide or make provision for additional apparatus or parking devices for the payment of a parking charge at any parking place.
13. The Council may upon the suspension of any parking place or any part thereof under the provisions of either Article 37 or Article 40 authorise the use of any parking place or part thereof for any purpose.

#### **PART IV**

#### **RESTRICTIONS ON USE OF PARKING PLACE**

14. On days and at the times other than those stipulated in column 3 of Schedules 3 to 5 when a parking place is not available for the parking of motor vehicles or is suspended no person shall park or leave or permit a motor vehicle to remain in any parking place.
15. The Council shall not be obliged to compensate any person for any loss or inconvenience or for any other reason caused by the locking of the entrance gates to any parking place during the times that the parking place is not available for the parking of motor vehicles or is suspended.
16. The driver of a vehicle shall not leave a vehicle in a parking place during charging hours or during availability times for a period longer than the maximum waiting period permitted for that parking place specified in column 5 of Schedules 3 to 5 or longer than the time or period paid for or stated on any parking pass issued to the driver.
17. The driver of a vehicle shall remove or cause to be removed that vehicle from the parking place, on or before the expiry of the period paid for or stated on any parking ticket or parking pass issued to the driver, and shall not re-park that vehicle within that parking place within the "No return within" period (if any) stated within column 5 of Schedules 3 to 5.



18. Articles 16 and 17 shall not apply on any Sunday, Christmas Day, Good Friday and any other day that is a public bank holiday in England when no parking charge shall be required to be paid when a vehicle is left in any parking place during charging hours and there are no restrictions on the length of stay and no restriction on re-parking.
19. Where in column 4 of Schedules 3 to 5 a parking place is described as available for motor vehicles of a specified class the driver of a motor vehicle shall not enter into that parking place or leave a motor vehicle in that parking place unless it is:-
  - 19.1. of the specified class and;
  - 19.2. left in a position specified for that class of motor vehicle and;
  - 19.3. left in a position within the parking place specified for the parking of motor vehicles of the class of a parking pass (if any) displayed on the motor vehicle.
20. The driver of a motor vehicle shall not drive that motor vehicle into or within a parking place unless:-
  - 20.1. that person is the holder of a driving licence authorising him or her to drive a motor vehicle of its class or description on a public highway; or,
  - 20.2. that person is the holder of a provisional driving licence and is riding a motorcycle which the rider may lawfully ride under the provisions of a provisional licence or in any other case is accompanied in or on that motor vehicle by a person holding a driving licence of the type mentioned in Article 20.1;
  - 20.3. the motor vehicle is licensed in accordance with the provisions of the Vehicle Excise and Registration Act 1994; and,
  - 20.4. there is in relation to the use of the motor vehicle by the driver such a policy of insurance as complies with the requirements of the Road Traffic Act 1988.
21. Unless the driver has a parking pass the driver of a motor vehicle shall not drive that motor vehicle into a parking place unless:-
  - 21.1. the motor vehicle and any trailer are below the maximum permitted height stated upon any notice at the entrance to such parking place; and,

- 21.2. the motor vehicle and any trailer are below the maximum weight permitted under this Order.
22. Unless the Council has issued a notice of suspension under the provisions of either Articles 37 or 40 together with its consent under the provision of Article 13, no person shall use any parking place or any part of a parking place for any purpose other than for the parking of vehicles of the class stipulated in column 4 of Schedules 3 to 5 and in particular (but not by limitation) no person in any parking place shall:-
- 22.1. hold any public or private meeting or rally or event or display or show (for example market, charity event, entertainment, educational, sporting or similar events) or deliver or collect any goods or animals in connection therewith; or,
  - 22.2. use on any motor vehicle or trailer any auxiliary motor or generator except when arriving in or about to change the position of the vehicle in or about to depart from the parking place; or,
  - 22.3. drive any motor vehicle into or within a parking place other than for the purpose of leaving that motor vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place; or,
  - 22.4. play any musical instrument or radio or wantonly shout or otherwise make any loud noise so as to cause disturbance or annoyance to other users of the parking place or to occupiers of premises in the neighbourhood; or,
  - 22.5. erect any tent booth building or other structure; or,
  - 22.6. light or cause or permit to be lit any fire; or,
  - 22.7. consume any alcohol; or,
  - 22.8. play with or without motor vehicles any sport or game or cycle skateboard skate or do any other similar thing; or,
  - 22.9. service repair or wash any vehicle other than is reasonably necessary to enable that vehicle to depart from the parking place; or,
  - 22.10. do anything in connection with any trade or business or for the private sale or advertising for sale or hire of any goods including motor vehicles skills or services; or,
  - 22.11. advertise or promote any cause, religion, event or other matter whatsoever or distribute leaflets or other material; or,
  - 22.12. place skips or similar storage receptacles or store goods rubbish or waste of any description howsoever short or long the period; or,
  - 22.13. prepare and sell hot or cold food and/or drinks.



22.14. wash crockery cutlery clothing or any other articles or things whatsoever; or,

22.15. sleep or camp overnight.

23. No person in a parking place shall:

23.1. drive or cause or permit to be driven any motor vehicle where signs are erected or surface markings are laid for the purpose of:-

23.1.1. indicating the entrance to or exit from the parking place; or,

23.1.2. indicating that a motor vehicle being driven within the parking place shall proceed in a particular direction;

such that a motor vehicle either enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit, or proceeds within the parking place in a direction other than that indicated; or,

23.2. drive any motor vehicle above the speed of ten miles per hour or, drive around such parking place unnecessarily, recklessly, erratically, dangerously, or play any game or sport involving motor vehicles or motor sport, motor rally or motor trial; or;

23.3. excepting in an emergency sound any horn or similar device; or,

23.4. use any motor vehicle (intentionally or otherwise) in such a manner as to generate any excessive engine noise or fumes or cause the tyres to skid unnecessarily; or,

23.5. leave or permit to be left running the engine of a motor vehicle any longer than is necessary for the parking of that motor vehicle or for the purpose of changing the position of the motor vehicle or departing from the parking place; or,

23.6. if that person is the driver of a motor vehicle alight from or leave the motor vehicle whilst the engine is running; or,

23.7. use any threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned; or,

23.8. commit any criminal offence; or,



- 23.9. leave any shopping or other trolley, basket on wheels or other similar receptacle designed for the carrying of merchandise in any parking place unless it is left in a location within the parking place that is designated by signs for the specific purpose of temporary storage of shopping trolleys.
24. Motor vehicles left within a parking place where parking bays or coach parking bays are provided shall be parked only within such bays both centrally and wholly within the said bay.
25. Market traders motor vehicles left in Shepherds Spring Lane parking place number 28 on market days may if unavoidable straddle parking bays but shall not be left such that they obstruct the access ways or roads within the parking place.
26. Motor vehicles shall not be left within a parking place in a position such that the motor vehicle or any load upon it may obstruct the parking of other motor vehicles in any adjoining parking bay or coach parking bay or unduly hinder the opening of the doors thereto.
27. In parking places where both buses and coaches are permitted to wait, buses shall be left in coach parking bays where available.
28. Vehicles shall not be left within a parking place such that any wheel is either wholly or partly upon any area of landscaping or upon any access way or road.
29. No person shall use a parking place as a means of passage or proceeding from one highway to another highway.
30. No person shall leave a trailer within a parking place unless the motor vehicle drawing it is attached.
31. Unless a motor vehicle with trailer attached can fit wholly within a single parking bay they shall be left only within two parking bays that are end to end.
32. For the purposes of this Order the driver of a motor vehicle shall be deemed to be the driver of both the motor vehicle and any trailer.
33. No person shall within a parking place do anything to interfere with the use and enjoyment thereof by other users and in particular (but not by limitation) no person shall:
- 33.1. obstruct or misuse any parking place and no person shall within a multi-storey car park obstruct or misuse the ramps stairs doors or lifts thereto; or,

- 33.2. soil or defile remove displace or damage any wall or fence in or enclosing the parking place, or any building, barrier, post, notice, sign, railing, parking device or any other erection therein; or,
  - 33.3. throw down, drop or otherwise deposit in any parking place any litter or rubbish or waste material; or,
  - 33.4. permit any animal to urinate or to defecate without immediately removing its faeces from the parking place.
34. No person shall drive any motor vehicle into a parking place when there is exhibited at the entrance to the parking place a notice indicating that the parking place is full.
35. Persons using any parking place do so at their own risk and the Council shall not be liable to pay compensation to any person in respect of any loss or damage to that persons property howsoever caused by virtue of the use of a parking place by that person as a parking place or otherwise.
36. No person shall cause or permit any vehicle to be left:
- 36.1. in Marlborough Street Andover (adjacent to east side of Anton House), parking place number 12 between the hours of 08:00 hours to 18:00 hours on Mondays to Fridays inclusive which between those hours is reserved for the exclusive use of the owner or occupiers of Anton House, Chantry Street, Andover their employees and visitors to Anton House; or,
  - 36.2. in any parking bay in any parking place which by ground markings and/or signs or notices is reserved for the charging of electrically propelled motor vehicles unless:
    - a) the motor vehicle is an electrically propelled motor vehicle which is in the process of receiving an electrical charge from the adjacent electricity charging point; and,
    - b) the electrically propelled motor vehicle is exempt from the requirement to pay a parking charge or the driver has a parking pass or season ticket valid for that vehicle and at that parking place. The driver is responsible for the payment of any parking charge whilst the vehicle is left in any such electricity charging parking bay in addition to the cost of electricity purchased and upon completion



of the charging cycle the electrically propelled motor vehicle shall be removed from the electricity charging parking bay; or,

- 36.3. in High Street (south end) Andover parking place number 1 on any day that is a market day unless such motor vehicle is a market traders motor vehicle and is authorised in writing by the Market Manager to be left there; or;
- 36.4. in Chantry Centre Multi-storey car park (Level 1a only) Andover parking place number 10 in those parking bays which, by ground markings and/or notices are reserved for the exclusive use by registered users of Andover Shopmobility, displaying an Andover Shopmobility permit unless there is displayed upon the motor vehicle an Andover Shopmobility permit and such motor vehicles may be left in those parking bays for a period not exceeding three hours; or.
- 36.5. in Alma Road (eight bays) Romsey parking place number 45 which is reserved for the exclusive use (subject to the purchase of an Alma Road Romsey season ticket at the charge stipulated in Schedule 2) by the owners or occupiers of the dwellings situate and known as numbers 38 to 60 inclusive (even numbers only) Alma Road Romsey PROVIDING FIRSTLY that any such owner or occupier shall be entitled to purchase only one Alma Road season ticket per address and PROVIDING SECONDLY that in the event that any Alma Road Romsey season ticket remains unsold then the Council will consider applications by any person for the purchase of either a quarterly or an annual season ticket at the standard rate charge stipulated in Schedule 2. AND PROVIDED THIRDLY that any owner or occupier of numbers 38 to 60 inclusive (even numbers only) Alma Road Romsey that has not already purchased an Alma Road Romsey season ticket shall have priority when current Alma Road Romsey season tickets expire; or,
- 36.6. in Beech Hurst, Weyhill Road, Andover, parking place number 60 for any period longer than two hours unless there is displayed upon the vehicle a parking pass valid for that parking place; or,
- 36.7. in those parking bays in any parking place which, by ground markings and/or notices, are reserved exclusively for disabled persons' motor vehicles unless there is displayed upon the vehicle a valid disabled persons badge and disc; or,



- 36.8. in any part of any parking place which by ground markings and/or by signs or notices are marked "taxi rank" unless such motor vehicle is a PLG motor vehicle which is a licensed hackney carriage displaying a hackney carriage plate which may wait without payment of any parking charge in such taxi rank only for the purpose of awaiting fares. The driver shall pay a parking charge if such licensed hackney carriage is left in any parking bay that is not a taxi rank; or,
- 36.9. in any part of any parking place which by ground markings and/or by signs or notices are marked "private hire / taxi pick up drop off point" unless; such motor vehicle is a PLG motor vehicle which is a licensed hackney carriage or private hire vehicle which may wait for a maximum of 10 minutes only without payment of any parking charge in such private hire / taxi pick up drop off point for the purpose of awaiting fares and the driver shall pay a parking charge if such licensed hackney carriage or private hire vehicle is left in any parking bay that is not a private hire / taxi pick up drop off point; or,
- 36.10. in any area within a parking place which by ground markings and/or by signs or notices is marked "coach drop off" unless such motor vehicle is a coach and is waiting for a maximum period of ten minutes for the purpose of picking up or dropping off passengers; or,
- 36.11. between 08:30 hours and 18:00 hours Mondays to Saturdays inclusive in any parking bay in any parking place which by ground markings and/or notices, are reserved for the exclusive use of season ticket holders unless there is displayed upon that motor vehicle in the relevant position a season ticket valid for that motor vehicle and that parking place; or,
- 36.12. in any parking place or parking bay indicated by markings and/or signs for use by residents permit holders motor vehicles unless that motor vehicle displays either a residents permit or visitors permit valid for that parking place; or,
- 36.13. upon the loading area indicated by ground markings cross hatched in yellow and/or notices within Princes Road, Romsey parking place number 51 unless that motor vehicle is either delivering goods to or collecting goods from Romsey Library and there is displayed in the relevant position upon that motor vehicle a parking pass issued by the staff within Romsey Library and the stay is for less than one hour; or,

36.14. wait upon the loading/unloading area indicated by ground markings and/or signs or notices, in High Street (south end) Andover parking place number 1 which is reserved for either:-

36.14.1. the loading or unloading of goods vehicles of a maximum length of 5.5 metres displaying an High Street, Andover permit PROVIDED THAT the loading or unloading shall not take place between 10.00 am and 6.00 pm Monday to Saturday inclusive, or at any time when a market is being held in High Street, Andover; or

36.14.2. the alighting from or the boarding of a motor vehicle by the holder of a disabled person's badge; or,

36.15. in Church Road, Romsey parking place number 52 (adjoining the Former Magistrates Court), between 08:30 and 16:00 hours Monday to Friday inclusive, in any bay indicated for use only by visitors to the offices of Test Valley Borough Council situated within the adjoining The Former Magistrates Court, Church Road, Romsey unless there is displayed on the vehicle a Test Valley Borough Council visitors permit. Hampshire County Council visitors permits are not valid in bays designated for Test Valley Borough Council visitors permits; or

36.16. in Church Road, Romsey parking place number 52 (adjoining the Former Magistrates Court), between 08:30 and 16:00 hours Monday to Friday inclusive, in any bay indicated for use only by visitors to the offices of Hampshire County Council situated within the adjoining The Former Magistrates Court, Church Road, Romsey unless there is displayed on the vehicle a Hampshire County Council visitors permit. Test Valley Borough Council visitors permits are not valid in bays designated for Hampshire County Council visitors permits.

## **PART V**

### **SUSPENSION OF PARKING PLACE**

37. The Council may upon application by any person for any reason suspend the use of a parking place or any part thereof provided the Council considers such reason necessary and such suspension may be subject to conditions including provisions in respect of the payment of lost revenue.



38. Any suspension of the use of a parking place by the Council under the provisions of this Article shall be effected by the service by the Council upon the applicant of a notice of suspension and the applicant shall not presume any parking place to have been suspended by the Council unless the applicant has received such notice.
39. Following receipt of a notice of suspension of a parking place the applicant shall comply with any conditions imposed by the Council in respect thereof and unless such obligation is reserved by the Council the applicant shall place or cause to be placed in or adjacent to that parking place or that suspended part thereof a notice or traffic sign indicating that the use of that parking place or that part thereof is suspended and shall maintain in place such notice or traffic sign throughout the period of suspension specified within the notice of suspension and shall remove the same immediately upon expiry of the said period.
40. The Council may at its own discretion suspend the use of a parking place or any part of a parking place and thereafter may designate that part of such parking place to be reserved for any purpose it may decide.
41. Unless authorised under the provisions of Article 13 no person shall cause or permit a motor vehicle to be left in a parking place or any part thereof during such periods that the use of that parking place or that part thereof is suspended or during such period as there is in or adjacent thereto a notice or traffic sign placed in pursuance of Article 39.

## **PART VI**

### **PAYMENT FOR PARKING**

42. Unless either the driver or the vehicle is exempt from the requirement to pay a parking charge or the driver has displayed either a parking pass or season ticket valid for the motor vehicle and the parking place, and (depending upon the nature of the parking device provided by the Council in each parking place for the payment of the parking charge) the driver shall immediately upon parking a motor vehicle in a parking place, either pay the parking charge (pay upon entry), or register the motor vehicle for the later payment of the parking charge (pay upon exit).
43. Payment of the parking charge shall be made in every case in accordance with the conditions and instructions displayed in the parking place and using any parking device



provided by the Council at the parking place for payment of the parking charge in that parking place being (for example, but not by limitation) by means of:

- 43.1. the purchase of a parking ticket, from a parking ticket dispensing machine; or,
  - 43.2. through any electronic cashless payment facility provided by the Council either through a parking device located within the parking place or remotely using the drivers own computer device, smart or touch tone cellular telephone, debit or credit card or prepaid card system.
44. Where alternative parking devices for payment of the parking charge are provided but one or more of them are defective then the driver shall pay the parking charge using one of the alternative parking devices.
45. Upon any occasion when a vehicle is left in a parking place during charging hours when all parking devices provided by the Council (as opposed to a computer smart phone or touch tone telephone provided by the driver) are inoperable the driver of that vehicle shall be exempt from the requirement to pay a parking charge on that occasion only.
46. The parking charge to be paid shall be that stipulated in Schedule 1 Parking Charges and Time Limits.
47. Pay on entry parking tickets shall be displayed in the relevant position on the vehicle at all times whilst the vehicle is left in the parking place.
48. Subject to any maximum permitted waiting period the driver of a vehicle shall ensure that the correct parking charge is paid to cover the entire period during charging hours that a vehicle is left in a parking place whether or not the driver remains with the motor vehicle.
49. A parking ticket may be displayed only on the vehicle for which the parking ticket was purchased.
50. A parking ticket for a trailer may be displayed in the relevant position upon the motor vehicle by which it is drawn.

**PART VII**  
**EXEMPTIONS FROM PARKING CHARGE**

51. The following motor vehicles shall be exempt in the circumstances described below from the obligation to pay a parking charge for parking during the charging hours set out in column 2 for parking of motor vehicles specified in column 4 in Schedules 3 to 5:
- 51.1. Subject to Article 51.2 below a disabled persons motor vehicle upon which is displayed in the relevant position a disabled persons badge and disc may be left:-
- a) for a period of up to 3 hours in any parking places referred to in Schedule 3 which have a maximum waiting period of either 2 or 3 hours; or,
- b) for a period up to the maximum permitted waiting period in any parking places referred to in Schedule 3 which have a maximum waiting period of all day.
- 51.2. A disabled persons motor vehicle upon which is displayed in the relevant position a disabled persons badge may be left in High Street Andover (south end) parking place number 1 between 08:30 hours and 18:00 hours on any Monday, Tuesday, Wednesday and Friday that is not a market day for a maximum period of 2 hours with no return within 1 hour.
- 51.3. A solo motorcycle left in a solo motorcycle parking bay.
- 51.4. A motor vehicle upon which is displayed in the relevant position a Council member's permit whilst such member is engaged on Council business may be left for a period up to the maximum permitted waiting period in any parking places referred to in Schedule 3 .
- 51.5. A motor vehicle upon which is displayed in the relevant position a Council staff permit issued to an officer of the Council which is marked "Monday to Friday inclusive" or marked "Monday to Saturday inclusive" whilst such officer is engaged on Council business may be left for a period up to the maximum permitted waiting period in any parking places referred to in Schedule 3.
- 51.6. A PLG motor vehicle upon which there is displayed in the relevant position a parking permit for the parking place in which that vehicle is left, and if specified,

for the specific bays indicated either in the parking place or upon the parking permit, for the duration stated on the parking permit only.

- 51.7. Motor vehicles belonging to the occupiers of Anton House their employees and visitors left in Marlborough Street Andover (adjacent to east side of Anton House) parking place number 12 Monday to Friday inclusive between 08:00 and 18:00 hours.
- 51.8. Licensed hackney carriages parked in accordance with Articles 36.8 and 36.9.
- 51.9. Disabled persons motor vehicles parked in accordance with Articles 36.7 and 51.1 and 51.2.
- 51.10. Council liveried vehicles may be left whilst on official Council business in any parking place during the days and times of availability stipulated in column 3 of Schedule 3. Unless a valid parking pass is displayed in the relevant position on such vehicles, waiting shall be restricted to the maximum waiting period stipulated in column 5 of Schedule 3.

## **SEASON TICKETS**

- 52. The Council may (subject to the availability of season ticket parking bays) permit a person to purchase one or more season tickets in respect of any parking place indicated by the word "Yes" in column 6 of Schedules 3 to 5 for use in the parking place named on the season ticket only.
- 53. The Council shall be at liberty to determine from time to time the number of season tickets to be sold in each parking place which determination shall be based upon fluctuating demand for parking.
- 54. If the owner of a motor vehicle wishes to purchase a season ticket such owner shall apply to the Council and if the Council agrees to issue a season ticket the applicant shall pay to the Council the season ticket parking charge specified in Schedule 2 for the appropriate parking place and the said owner shall abide by the terms stipulated by the Council for the use of such season ticket.
- 55. The Council shall be at liberty to offer for sale annual season tickets for Chantry Centre Multi-storey Car Park and Shepherds Spring Lane Car Park, when purchased (subject



to availability) in quantities of one hundred or more at the reduced rates stipulated in Schedule 2.

56. A season ticket may be used only in the parking place in respect of which it is issued.
57. In those parking places where season ticket parking bays are segregated from non-season ticket parking bays the driver of a motor vehicle with the benefit of a season ticket shall park that motor vehicle only in a parking bay indicated by markings and/or signs for season ticket holders motor vehicles.
58. A season ticket shall be displayed in the relevant position on the motor vehicle.

#### **RESIDENTS PERMITS AND VISITORS PERMITS**

59. The Council may upon application issue one residents permit and/or one visitors permit to a person whose usual place of residence is at premises appearing on a list approved by the Council as being eligible.
60. Residents Permits and Visitors Permits:
  - 60.1. shall not be used with any motor vehicle other than a PLG motor vehicle.
  - 60.2. may only be used in the parking place for which they were issued.
  - 60.3. shall be displayed in the relevant position whilst the PLG motor vehicle is left in the parking place in respect of which it was issued.
61. Residents permits shall be used only with the motor vehicle in respect of which it was issued.
62. Visitors permits shall be used only by:
  - a) persons whose usual place of residence is not at that residence in respect of which a visitors permit was issued for the purpose only of visiting the said residence in respect of which the visitors permit was issued; and,
  - b) a resident to whom the visitors permit has been issued.

**PART VIII**  
**PARKING OFFENCES**

63. Any person responsible for a breach of any provision within this Order shall be guilty of an offence under the provisions of Section 35A.(1) of the 1984 Act (Offences and proceedings in connection with parking places provided under s.32 or 33) and Section 73 of the 2004 Act (Contraventions subject to civil enforcement) shall apply to this Order.
64. The Council may treat the indications given by any apparatus or parking device provided by the Council for the payment of the parking charge as a means to indicate the time at which a vehicle arrived at, and at the time at which it ought to leave a parking place or, or one or other of those times.
65. The provisions of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007 (No. 3483) apply to penalty charges for parking contraventions in respect of this Order.
66. The Council has elected for the purposes of The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges)(England) Order 2007 to set the levels of penalty charges for higher level contraventions (as defined in the said Order) and for lower level contraventions at the rates stipulated in Schedule 2.

**PAYMENT OF A PENALTY CHARGE**

67. Penalty charges shall not be paid to a parking attendant or civil enforcement officer, neither of whom are authorised to accept them.
68. Penalty charges shall be paid in accordance with the instructions printed on the back of the PCN to reach the Council no later than 16:30 hours by the date specified on the PCN but should Council Office be closed on the said date specified the period for receiving payment may be extended until 16:30 hours on the next full working day.

**PART IX**  
**REMOVAL OF VEHICLES**

69. On any occasion when a vehicle is left in a parking place in contravention of any of the provisions of this Order a parking attendant or civil enforcement officer or other person authorised by the Council may alter or cause to be altered the position of such vehicle in order that its position shall comply with that provision or may remove or arrange for the vehicle to be removed from a parking place and for the safe custody of that vehicle.
70. Any person removing or altering the position of a vehicle by virtue of this Article may do so by lifting or towing or driving the vehicle or in such other manner as he/she may consider necessary and that person may take such measures in relation to the vehicle as he/she may consider necessary to enable him/her to remove the vehicle or alter its position as the case may be.
71. In case of emergency any person authorised by the Council may move or cause to be moved or removed any motor vehicle from any parking place to any location that that person considers appropriate.
72. When a vehicle has been removed from a parking place under the provisions of this Order, the costs of removal and for its safe custody shall be the liability of the driver and in the event that the driver cannot be either identified or traced then the person appearing to the Council to be the owner of the vehicle shall be liable for such charge.
73. The vehicle removal charge stipulated in Schedule 2 shall be paid to the Council in respect of either moving a vehicle within a parking place or removal of a vehicle from a parking place.
74. The vehicle storage charge stipulated in Schedule 2 shall be paid to the Council in addition to the vehicle removal charge for each day or part of a day that a vehicle is stored by the Council under the provisions of Article 69.
75. If it appears to the Council that any vehicle within any parking place has been abandoned, The Council may remove it or arrange to have it removed; or, if the Council exercise its Statutory powers of removal of an vehicle found abandoned within any parking place which vehicle is subsequently disposed of by the Council then in addition to the vehicle removal charge and the vehicle storage charge the owner shall pay to the Council the vehicle disposal charge stipulated in Schedule 2.



**PART X**  
**VALIDITY, ENFORCEABILITY**

76. If a court, the Department for Transport, the Traffic Penalty Tribunal or the Traffic Enforcement Centre declare any part of this Order to be invalid or unenforceable such declaration shall not invalidate the remainder of the Order.




**Map Showing Off Street  
Car Parking Romsey**

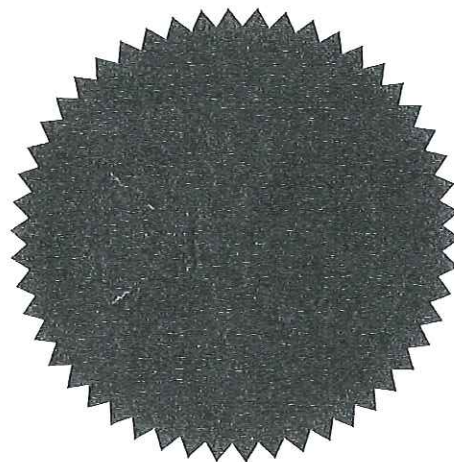
