**THE BOROUGH COUNCIL OF TEST VALLEY
(VARIOUS ROADS, ANDOVER)
(PROHIBITION OF DRIVING) ORDER 2006**

The Borough Council of Test Valley, as agent for Hampshire County Council in exercise of its powers under Sections 1, 2 and 3(2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, Part IV of Schedule 9 to the Act, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. Save as provided in article 2 of this Order, no person shall cause any vehicle to proceed in the entire lengths of road specified in the Schedule to this Order.
2. Nothing in article 1 of this Order shall apply so as to prevent any person from causing any pedal cycle to proceed in the roads referred to in that article or so as to prevent any person from causing any vehicle to proceed in the road referred to in that article if the vehicle is being used:
 - (a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that road;
 - (b) in connection with any building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic in that road, the maintenance improvement or reconstruction of that road, or the laying, erection, alteration or repair in or adjacent to that road of any sewer or of any main, pipe or apparatus for the supply of gas, water, electricity or telecommunications.
3. This order shall come into operation on the 17 October 2006 and may be cited as "The Borough Council of Test Valley (Various Roads, Andover) (Prohibition of Driving) Order 2006".

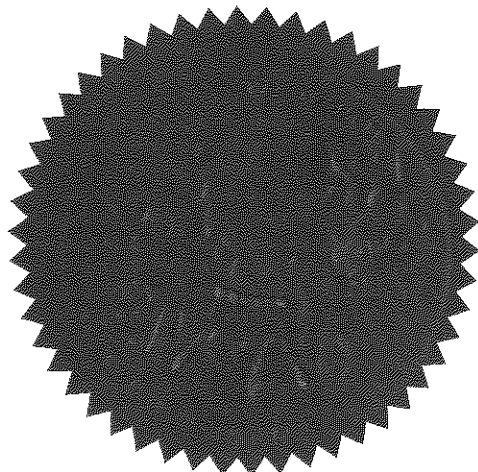
