THE BOROUGH OF TEST VALLEY (JUNCTION OF STATION APPROACH AND JUNCTION ROAD, ANDOVER) (PARKING PLACES AND PROHIBITION OF DRIVING) (VARIATION OF THE BOROUGH OF TEST VALLEY (PARKING PLACES AND RESTRICTION OF WAITING) (ANDOVER) VARIATION ORDER 2012) ORDER 2012

The Borough Council of Test Valley as agent for Hampshire County Council (being the Traffic Authority) in exercise of its powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

I. VARIATION OF ORDERS

- 1. In this order
 - a) "the 2012 Order" means The Borough of Test Valley (Parking Places and Restriction of Waiting) (Andover) Variation Order 2012, and
 - b) "the 2009 Order" means The Borough of Test Valley (Station Zone, Andover) (Parking Places and Restriction of Waiting and Stopping) (Controlled Zone) Order 2009.
- 2. The 2012 Order shall have effect as though the words "Moore Court" in Schedule 11 of the 2012 Order were deleted therein and the words "Moore Close" were included therein.
- 3. The 2009 Order shall have effect as though the parking places as set out in Schedule 1a hereto were deleted therein and the parking places as set out in Schedule 1b hereto were included therein.
- 4. The 2009 Order shall have effect as though the lengths of roads with no waiting at any time as set out in Schedule 2a hereto were deleted and the lengths of roads with no waiting at any time as set out in Schedule 2b hereto were included therein.
- 5. The 2009 Order shall have effect as though the lengths of roads with no waiting as set out in Schedule 3a hereto were deleted and the lengths of roads with no waiting as set out in Schedule 3b hereto were included therein.

- 6. The 2012 Order shall have effect as though the lengths of roads with no waiting at any time as set out in Schedule 4a hereto were deleted and the lengths of roads with no waiting at any time as set out in Schedule 4b hereto were included therein.
- 7. The 2009 Order shall have effect as though the lengths of roads with no stopping except for buses as set out in Schedule 5 hereto were deleted there from.

II. NEW PROHIBITION OF DRIVING

- 8. No person shall cause any vehicle to proceed in that length of the southern spur of Station Approach Andover in front of numbers 37 to 45 Station Approach shown edged by dashed lines on the Plan attached hereto save to gain access and egress for parking purposes only.
- 9. This Order shall come into operation on the 20th May 2012 and may be cited as "The Borough of Test Valley (Junction of Station Approach and Junction Road, Andover) (Parking Places and Prohibition of Driving) (Variation of The Borough of Test Valley (Parking Places and Restriction of Waiting) (Andover) Variation Order 2012) Order 2012".


