

TEST VALLEY BOROUGH COUNCIL**ROAD TRAFFIC REGULATION ACT 1984****THE BOROUGH OF TEST VALLEY (HALTERWORTH LANE, ROMSEY)
(PROHIBITION AND RESTRICTION OF WAITING) ORDER 2008**

The Borough Council of Test Valley as agent of Hampshire County Council (being the Traffic Authority) in exercise of its powers under Sections 1, 2, 3, 4, 45, 46, 49 and 51 of the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Regulation (Parking) Act, 1986, Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

PART 1 – GENERAL

1. In this order

"the Council" means Hampshire County Council or, as the case may be, The Borough Council of Test Valley acting as Hampshire County Council's agents.

2. The Prohibitions and restrictions imposed by this order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

PART II – RESTRICTION AND PROHIBITION OF WAITING

3. Save as provided in article 4 of this order, no person shall, except upon the direction or with the permission of a police constable in uniform or civil enforcement officer, cause or permit any vehicle to wait:-
 - (i) at any time on the sides of road specified in schedule 1 to this order;
 - (ii) between the hours of 8.00am and 9.00 am and between the hours of 2.00pm and 4.00 pm from Monday to Friday (both days inclusive) on the sides of road specified in schedule 2 to this order;
4. Nothing in article 3 of this order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of road referred to in that article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;

- (b) to enable goods to be loaded onto or unloaded from the vehicle;
- (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with the following operations namely:-
 - (i) the removal of any obstruction to traffic;
 - (ii) the maintenance, improvement or reconstruction of the said sides of road;
 - (iii) the laying, erection, alteration or repair in, or in land adjacent to, the said sides of road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or telecommunications;
- (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
- (e) to enable the vehicle to be used in the service of the Post Office for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
- (f) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said sides of road;
- (g) to enable the vehicle to wait at or near to any premises situated on or adjacent to the said sides of road for so long as is reasonably necessary in connection with any wedding or funeral; or
- (h) to enable the vehicle to be used for fire and rescue service, ambulance or police purposes.

5. This order shall come into operation on the 30 January 2009 and may be cited as "The Borough of Test Valley (Halterworth Lane, Romsey) (Prohibition and restriction of Waiting) Order 2008".

SCHEDULE 1		No waiting at any time
Road in Romsey	Side	Length of Road
Halterworth Lane	Both	From its junction with Botley Road to a point 20 metres north.
Botley Road	North	From a point 10 metres west of its junction with Halterworth Lane to a point 10 metres east of the same junction.
Halterworth Lane	Both	From a point 10 metres south of its junction with Montfort Heights to a point 10 metres north of the same junction.
Montfort Heights	Both	From its junction with Halterworth Lane to a point 10 metres west.
Halterworth Lane	Both	From a point 10 metres south of its junction with Benedict Close to a point 10 metres north of the same junction.
Benedict Close	Both	From its junction with Halterworth Lane to a point 10 metres west.
Halterworth Lane	Both	From a point 15 metres south of its junction with Saxon Way to a point 15 metres north of the same junction.
Saxon Way	Both	From its junction with Halterworth Lane to a point 15 metres west.

SCHEDULE 2		No waiting from 8 am to 9 am and from 2 pm to 4 pm Mondays to Friday
Road in Romsey	Side	Length of Road
Halterworth Lane	East	From a point 50 metres north of Benedict Close to a point 35 metres further north.
