

**THE THANET DISTRICT COUNCIL
(OFF-STREET PARKING PLACES) ORDER 2003**

The Thanet District Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984"), and of all other enabling powers, and with the consent of the Kent County Council given under section 39(3) of the Act of 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

PART I

GENERAL

CITATION, COMMENCEMENT and REVOCATIONS

1. (1) This Order shall come into operation on 1st day of September, 2003 and may be cited as the Thanet District Council (Off-Street Parking Places) Order 2003

(2) The Thanet District Council (Off-Street Parking Places) Order 1996 as varied is revoked.

2. (1) In this Order, except where the context otherwise requires the following expressions have the meanings hereby respectively assigned to them:-

"the Act of 1984" means the Road Traffic Regulation Act 1984;

"the Council" means the Thanet District Council;

"chargeable hours" means the times specified in an item in column 5 of Schedule 2 appropriate to the parking place named in column 1 of that Schedule;

"disabled person" and "disabled person's badge" have the same meaning as in the Disabled Persons' (Badges for Motor Vehicles) Regulations 2000;

"disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge and which is a vehicle which, immediately before or after any period of waiting allowed by virtue of a provision of a kind required by the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 to be included in an Order under the Act of 1984, has been or is to be driven by a disabled person or, as the case may be, has been or is to be used for carrying disabled persons as passengers;

"driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;

"owner" in relation to a vehicle has the same meaning as in section 142(1) of the Road Traffic Regulation Act 1984;

"parking attendant" has the same meaning as in section 63A of the Road Traffic Regulation Act 1984;

"parking authority" means -

in relation to a parking place which was provided or authorised under section 32(1) of the Road Traffic Regulation Act 1984, the Thanet District Council.

"parking place" means any area of land provided by the Council under section 32(1) of the Act of 1984 for use as a parking place and specified by situation and named in column 1 of Schedules 1 and 2 to this Order.

"parking space" means a space in a parking place which is provided for the leaving of a vehicle;

"parking ticket" means a ticket relating to a parking place issued by a ticket machine or a parking attendant;

"season ticket" means a ticket relating to a parking place issued by the Council and valid for more than one parking session.

"relevant position" means:-

In the case of a Disabled Person's Badge -

(a) A vehicle displays a disabled person's badge in the relevant position if:-

(i) in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from the outside the vehicle; or

(ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle.

(b) A vehicle displays a parking disc in the relevant position if:-

(i) in the case of a vehicle fitted with a dashboard or fascia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; or

(ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.

In the case of any other badge or permit -

A vehicle displays any other badge or permit in the relevant position if:-

(i) in the case of a vehicle fitted with a front windscreen, the item is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen;

(ii) in the case of a vehicle not fitted with a front windscreen, the item is exhibited in a conspicuous position on the front or near side of the vehicle.

In the case of a parking ticket -

A vehicle displays a parking ticket in the relevant position if the item is exhibited in a conspicuous position on the front or near side of the vehicle.

"ticket machine" means apparatus of a type and design approved either generally or specially by the Secretary of State for the purpose of the parking place, being apparatus designed to indicate the time and to issue parking tickets indicating the payment of a charge and the period in respect of which it has been paid;

(2) In this Order, except where the context otherwise requires:-

- (a) any reference to a numbered Article or a numbered Schedule is a reference to the Article or Schedule bearing that number in this Order;
- (b) any reference to a numbered or lettered paragraph or sub-paragraph is a reference to the paragraph or sub-paragraph bearing that number or letter in the Article or Schedule or (in the case of a sub-paragraph) paragraph in which the reference occurs; and
- (c) any reference to a Table, or to a numbered Table, is a reference to the Table, or to the Table bearing that number, in the Article or Schedule in which that reference occurs.

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment;

(4) The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under or having effect as if made under the Act of 1984 or by or under any other enactment;

(5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

USE OF LAND AND PARKING PLACE

- 3. (1) Each area of land specified by name in column 1 of Part 1 of Schedule 1 to this Order may be used, subject to the following provisions of this Order, as a parking place for such classes of vehicles, in such positions, and on such days and during such hours and for such vehicles displaying a permit issued by the Council as are specified in relation to that area in the said Schedule.

(2) Each area of land specified by name in column 1 of Part 2 of Schedule 1 to this Order may be used, subject to the following provisions of this Order, as a parking place for such classes of vehicles, in such positions, and on such days and during such hours as are specified in relation to that area in the said Schedule.
- 4. Each area of land specified by name in column 1 of Schedule 2 to this Order may be used, subject to the following provisions of this Order, as a parking place for such classes of vehicle, in such positions and on such days and during such hours as are specified in relation to that area in the said Schedule.
- 5. The driver of a vehicle shall not, except with the permission of any person authorised by the Council, permit that vehicle to wait in a parking place except during the days and hours of operation specified in the Schedules to this Order in relation to that parking place.
- 6. Where in the Schedules to this Order a parking place is described as available for vehicles of a specified class the driver of a vehicle shall not, except with the permission of any person authorised by the Council, permit that vehicle to wait in that parking place unless it is of the class specified.
- 7. Where the position in which a vehicle may wait in a parking place is specified in the Schedule to this Order the driver of a vehicle shall not, except with the permission of any person authorised by the Council, permit that vehicle to wait in that parking place in a position other than that specified.
- 8. Where in the Schedule to this Order a parking place is described as available for vehicles displaying a valid permit, the driver of a vehicle shall not, except with the permission of any person authorised by the Council, permit that vehicle to wait in that parking place unless it displays a valid permit as may be applicable.

9. Where within a parking place there is a sign or surface marking which indicates that a parking space is available only for a disabled person's vehicle the driver of a vehicle shall not permit that vehicle to wait in that parking space unless it is a disabled person's vehicle lawfully displaying a disabled person's badge in the appropriate position.
10. Where within a parking place there is a sign or surface marking which indicates that a parking space is available only for a vehicle with special permission or licence of the Council the driver of a vehicle shall not permit that vehicle to wait in that parking space unless that special permission or licence is displayed on the vehicle in the appropriate position.
11. Where within a parking place there is a sign or surface marking which indicates that a parking space is available only for the vehicle of a permit holder the driver of a vehicle shall not permit that vehicle to wait in that parking space unless that permit is displayed in the appropriate position.

PAYMENT OF PARKING CHARGE AT PARKING PLACES

12. (1) The driver of a vehicle using a parking place specified in Schedule 2 to this Order shall on leaving the vehicle in that parking place pay the appropriate parking charge in accordance with the Scale of Charges specified in column 7 of the said Schedule.

PROVIDED ALWAYS that nothing in this paragraph shall apply in respect of any vehicle which is waiting in a charged parking place and is displaying in the relevant position a Season ticket valid in respect of that vehicle and in respect of the parking space in which that vehicle is parked.

- (2) The parking charge shall be payable either

- (a) by the insertion of an appropriate coin or coins into the ticket machine provided, or

- (b) to the parking attendant, being a person authorised by or on behalf of the Council to receive such charge.

- (3) No person shall, except upon the direction or with the permission of a parking attendant, cause or permit any vehicle to wait during the chargeable hours in a charged parking place for longer than the parking period paid for on payment of the parking charge

- (4) The owner of a vehicle may on application to the Council purchase a season ticket in respect of that vehicle for a charge ascertained by reference to the Scale of Charges in Schedule 3 to this Order and that season ticket shall be valid in such parking places as are specified thereon during the period for which it is issued.

- (5) Any ticket issued on payment of the charge referred to in paragraph (1) of this Article and any season ticket issued in accordance with the provisions of paragraph (4) of this Article shall be displayed in the relevant position on or in the vehicle in respect of which it was issued.

MAXIMUM PERIOD VEHICLE MAY BE LEFT IN PARKING PLACE

13. The driver of a vehicle shall not, except with the permission of any person authorised by the Council, permit that vehicle to wait in a parking place for longer than the maximum period permitted in the Schedules for waiting in relation to that parking place.

EXEMPTION FROM PARKING CHARGE AND TIME LIMITS

14. The following vehicles left in a parking place shall be exempt from the payment of any charge specified in column 7 of Schedule 2 to this Order and from any limitation on time specified in column 6 of the said Schedule

- (a) an invalid carriage;
- (b) a vehicle issued to a disabled person by the Department of Health and Social Security in lieu of an invalid carriage;
- (c) a disabled person's vehicle which displays in a relevant position a disabled person's badge or parking disc.

OFFENCES IN RELATION TO VEHICLES

15. (1) An offence is committed and a penalty charge incurred if a vehicle is left in a parking place -

- (a) for longer than the period for which payment has been made in accordance with column 7 of Schedule 2 to this Order; or
- (b) contrary to the classes of vehicle permitted to park; or
- (c) for longer than the period for which vehicles may wait; or
- (d) without displaying a valid ticket, season ticket or permit; or
- (e) in a position reserved for either a disabled person's vehicle or vehicle with special permission, licence or permit of the Council; that vehicle not being appropriately a disabled person's vehicle or vehicle with special permission, licence or permit of the Council; or
- (f) in a position so as to obstruct access to the parking place or to any premises adjoining the parking place or to obstruct an accessway within the parking place.

ACTION BY PARKING ATTENDANTS

16. (1) Where, in the case of a stationary vehicle, a parking attendant has reason to believe that a penalty charge is payable with respect to the vehicle, he may-

- (a) fix a penalty charge notice to the vehicle; or
- (b) give such a notice to the person appearing to him to be in charge of the vehicle.

(2) A penalty charge notice must state -

- (a) the grounds on which the parking attendant believes that a penalty charge is payable with respect to the vehicle;
- (b) the amount of the penalty charge which is payable;
- (c) that the penalty charge must be paid before the end of the period of 28 days beginning with the date of the notice;

- (d) that if the penalty charge is paid before the end of the period of 14 days beginning with the date of the notice, the amount of the penalty charge will be reduced by one half
- (e) that, if the penalty charge is not paid before the end of the 28 day period, a notice to owner may be served by the parking authority on the person appearing to them to be the owner of the vehicle;
- (f) the address to which payment of the penalty charge must be sent.

INDICATION BY PARKING MACHINES AND TICKETS

17. If at any time while a vehicle is left in a parking place a ticket is attached to the vehicle in accordance with the provisions of Article 12(5) of this Order and the time shown on the clock of any apparatus or device or by the parking attendant referred to in Article 12(2) of this Order indicates that the period for which the vehicle may be parked as represented by such ticket has expired, it shall be presumed unless the contrary is proved that such period has expired.

SUSPENSION OF PARKING PLACES

18. The Council may, by Notice or by Order, suspend the use of any parking place or any part thereof subject to such conditions or exceptions as they consider necessary.

PROVIDED ALWAYS that any person suspending the use of a parking place in accordance with the provisions of this Article shall place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended such signs as are necessary to indicate that waiting by vehicles is prohibited.

MOVEMENT AND REMOVAL OF VEHICLES

19. (1) When a vehicle is left in a parking place in contravention of or non-compliance with any of the provisions of this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from that parking place.

(2) In case of an emergency a police constable or a person authorised in that behalf by the Council may alter the position of that vehicle in the parking place; or remove the vehicle or arrange for it to be removed from that parking place to any place he thinks fit.

20. Any person altering the position of a vehicle in, or removing a vehicle from, a parking place by virtue of the last preceding Article of this Order may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to remove it or alter its position, as the case may be.

SAFE CUSTODY OF VEHICLES REMOVED FROM PARKING PLACES

21. When a person authorised by the Council removes or makes arrangements for the removal of a vehicle from a parking place by virtue of Article 19 of this Order he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle

MISCELLANEOUS CONDITIONS

22. The driver of a vehicle shall not use a parking place

(a) so as unreasonably to prevent access to any premises adjoining a road or the use of a road by other persons or so as to be a nuisance;

(b) when such parking place has been closed in accordance with the provisions of the preceding Article of this Order.

23. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.

24. No person shall

(a) sell, offer or exhibit for sale or hire any vehicle while it is in a parking place, or

(b) use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills in handicraft or services in any capacity.

25. The driver of a motor vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place

26. No person shall except with the permission of any person authorised by the Council, drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.

27. No person shall in a parking place wantonly shout or otherwise make or cause to be made any loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood.

28. No person shall in a parking place use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.

29. No person shall in a parking place play or take part in any game.

30. No person shall use any part of a parking place or any vehicle left in a parking place:-

(a) for sleeping or camping purposes;

(b) for eating or cooking purposes;

(c) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable the vehicle to depart from the parking place; or

(d) for the purpose of washing any part of his person.

31. No person shall in any parking place without the consent of the Council distribute or affix to any vehicle left in the parking place any literature or leaflets of any nature.

32. No person shall use a parking place as a means of passage proceeding from one road to another road.

33. No person shall in a parking place without the consent of the Council distribute or affix to any vehicle left in the parking place any literature or leaflets of any nature.

34. Where in a parking place signs are erected or surface markings are laid for the purpose of -

(a) indicating the entrance to or exit from the parking place; or

(b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place

no person shall drive or cause or permit to be driven any vehicle (i) so that it entered the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit, so indicated or (ii) in a direction other than that specified, as the case may be.

35. In a parking place no person shall:-

(a) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council; or

(b) light or cause or permit to be lit any fire
