**THE HERTFORDSHIRE (NORTHWAY AND STATION ROAD
RICKMANSWORTH)(WAITING RESTRICTIONS) ORDER 2001**

The Hertfordshire County Council in exercise of their powers under Sections 1(1), 2(1) to (3) and 3 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby makes the following Order:-

1. This Order may be cited as "The Hertfordshire (Northway and Station Road, Rickmansworth) (Waiting Restriction) Order 2001" and shall come into operation on Monday 1 July 2002.

2. In this Order

"disabled person's vehicle" has the same meaning as in Section 142(1) of the Act of 1984.

"disabled person's badge" has the same meaning as in Section 142(1) of the Act of 1984.

"parking disc" means a disc, issued by a local authority, 125mm square, coloured orange or blue, and capable of showing the quarter hour period during which a period of waiting begins; and

"relevant position" means

- i) A vehicle displays a disabled person's badge issued before 2 March 1992 in the relevant position if:-
 - a) in the case of vehicle fitted with a front windscreen, the badge is exhibited thereon on the near side of and immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; and
 - b) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.

- ii) A vehicle displays a disabled person's badge issued on or after 2 March 1992 in the relevant position if:-
 - a) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - b) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle.

- iii) A vehicle displays a parking disc in the relevant position if:-
 - a) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter hour period during which the period of waiting began is legible from outside the vehicle; or
 - b) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter hour period during which the period of waiting began is legible from outside the vehicle.
- 3. Save as provided in Articles 5, 6 and 7 of this Order, no person shall, except under the direction or with the permission of a police officer in uniform or of a traffic warden, cause or permit any vehicle to wait at any time in the lengths of Northway and Solomon's Hill, Rickmansworth as specified in Schedules 1, 2 and 3 of this Order.
- 4. Save as provided in Articles 5, 6 and 7 of this Order, no person shall except upon the direction or with the permission of a police officer in uniform or a traffic warden, cause or permit any vehicle to wait between the hours of 8.00am and 7.00pm Monday to Saturday, waiting outside these times not to exceed 2 hours return prohibited within the next 1 hour in the lengths of Northway and Station Road specified in Schedule 4 of this Oder.
- 5. (1) Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein for so long as may be necessary to enable;
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - (i) building, industrial and demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said length of road;
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
 - (v) to a vehicle being used for fire brigade, ambulance or police purposes;
 - (c) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.
- 6. Nothing in Articles 3 or 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, to wait in the lengths of roads referred to in the said Article for a period of 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

7. The provisions of The Hertfordshire (Various Roads, Rickmansworth) (Waiting Restrictions) Order 2001 and The Hertfordshire (Various Roads, Moor Park, Rickmansworth) Order 2001 that relate to the whole length of Northway, Solomon's Hill and the eastside of Station Road from a point 15 metres north of its junction with Northway northwards for a distance of 45 metres are hereby revoked.
8. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
9. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE 1

Lengths of roads in Rickmansworth no waiting at any time - loading /unloading permitted

Northway -: Northway northern arm south side	From a point approximately 84 metres north west of its junction with westwards for a distance of approximately 15 metres up to the cul-de- sac end, around the turning head and to its junction with Solomon's Hill.
Station Road, east side	From its junction with Northway, northwards for a distance of approximately 13 metres.
Station Road, east side	From a point approximately 49 metres north of its junction with Northway, northwards for a distance of approximately 14 metres.

SCHEDULE 2

Lengths of road in Rickmansworth no waiting, loading unloading at any time

Northway north side	From its junction with Station Road, eastwards for 14 metres.
Northway north / east sides	From a point approximately 86 metres east of its junction with Station Road, eastwards and southwards to its junction with High Street.
Northway south / west sides	From a point approximately 180 metres east of its junction with Station Road, eastwards and southwards for a distance of approximately 52 metres to its junction with High Street.
Northway. - northern arm west & south sides	From its junction with Northway, northwards and westwards for a distance of approximately 84 metres.
Northway. - northern arm east & north sides	From its junction with Northway, northwards and westwards to its junction with Solomon's Hill a distance of approximately 100 metres
Solomon's Hill	From its junction with Northway (northern arm) northwards for its entire length

SCHEDULE 3

Lengths of roads subject to no waiting at any time -no loading / unloading 7.30 am to 9.30 and 4.30 pm to 6.30 pm Monday - Saturday

Northway south side	From its junction with Station Road eastwards for approximately 114 metres.

SCHEDULE 4

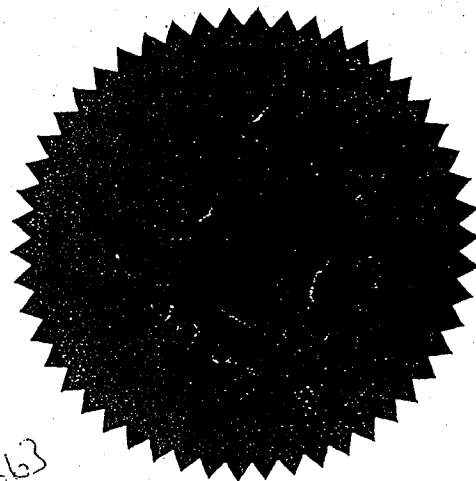
Lengths of road subject to no waiting 8.00am to 7.00pm Mon-Sat waiting limited to a maximum period of 2 hours no return within 1 hour

Northway north side From a point approximately 14 metres east of its junction with Station Road, eastwards for a distance of approximately 72 metres.


Station Road east side From a point approximately 13 metres north of its junction with Northway, northwards for a distance of approximately 36 metres.
