THE THREE RIVERS (STATION APPROACH, PRESTWICK ROAD, SOUTH OXHEY) (PROHIBITION OF WAITING OR STOPPING) ORDER 2002

The Three Rivers District Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hertfordshire County Council in exercise of the powers of the said County Council under Sections 1(1), 2(1), 2(2), 3 and 4 of the Road Traffic Regulation Act 1984, ("the Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:-

1. This Order shall come into operation on 22 November 2002 and may be cited as "The Three Rivers (Station Approach, Prestwick Road, South Oxhey) (Prohibition of Waiting or Stopping) Order 2002".

2. In this Order

'disabled person's vehicle' has the same meaning as in Section 142(1) of the Act

'disabled person's badge' has the same meaning as in Section 142(1) of the Act

'hackney carriage vehicle' has the same meaning as in Section 38 of the Town Police Clauses Act 1847 being a wheeled carriage, standing or plying for hire, having a valid numbered plate issued by the local District Council being the Three Rivers District Council

'parking attendant' has the same meaning as in Section 63A of the Act

'public service vehicle' has the same meaning as Section 1(1)(a) of the Public Passenger Vehicles Act 1981

'relevant position' means

- (a) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon on the near side of and immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; and

- (b) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.

A vehicle displays a parking disc in the relevant position if:-

- (a) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter hour period during which the period of waiting began is legible from outside the vehicle; or
 - (b) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter hour period during which the period of waiting began is legible from outside the vehicle..
3. Save as provided in Articles 8, 9 and 10 of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle to wait at any time in the lengths of Station Approach, South Oxhey specified in Schedule 1 of this Order.
 4. Save as provided in Articles 8, 9 and 11 of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle to wait at any time for a period in excess of 1 hour return prohibited within the next 1 hour in the lengths of Station Approach, South Oxhey specified in Schedule 2 of this Order.
 5. Save as provided in Article 8(b) of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle, other than a hackney carriage vehicle licensed with Three Rivers District Council to stop at any time in the lengths of Station Approach, South Oxhey specified in Schedule 3 of this Order.
 6. No person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle to wait at any time in the lengths of Prestwick Road, South Oxhey specified in Schedule 4 of this Order.
 7. Save as provided in Article 8 of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle, other than a public service vehicle, to wait between the hours of 7 a.m. to 7 p.m. in the lengths of Prestwick Road, South Oxhey specified in Schedule 5 of this Order.
 8. Nothing in Articles 3, 4, 5 and 7 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein for so long as may be necessary to enable:-
 - a) a person to board or alight from a vehicle;
 - b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - i) building, industrial and demolition operations;

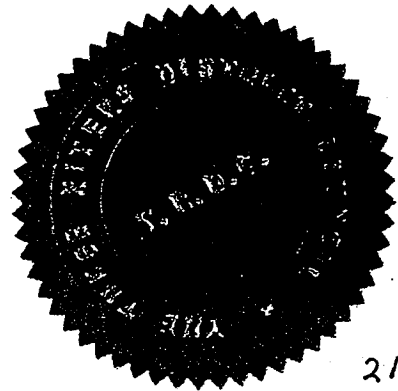
- ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said length of road;
 - iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
 - v) to a vehicle being used for fire brigade, ambulance or police purposes;
 - vi) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - vii) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.
9. Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle in any lengths of road specified in Articles 3 and 4 of this Order at any time on any day.
10. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in Article 3 of this Order for a period of 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
11. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait for any period of time in the lengths of road referred to in Article 4 of this Order.
12. The relevant sections of The Hertfordshire (Various Roads, Watford Rural Parish) (Waiting Restrictions) Order 2001 are hereby revoked insofar as they related to lengths of Station Approach and Prestwick Road affected by this Order.
13. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament.
14. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
