ROAD TRAFFIC REGULATION ACT 1984

THE THREE RIVERS DISTRICT COUNCIL (WINTON CRESCENT, CROXLEY GREEN) (PROHIBITION OF WAITING) ORDER 2004

The Three Rivers District Council (hereinafter referred to as "the Council") makes this Traffic Regulation Order pursuant to arrangements under Section 101 of the Local Government Act 1972 with the Hertfordshire County Council in exercise of the powers of the said County Council under Sections 1(1), 2(1), 2(2)(c), 4(1) and 4(2) of the Road Traffic Regulation Act 1984, ("the Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act.

1. This Order shall come into operation on 25 October 2004 and may be cited as "The Three Rivers District Council (Winton Crescent, Croxley Green) (Prohibition of Waiting) Order 2004".

2. In this Order

'disabled person's badge' has the same meaning as in Section 142(1) of the Act

'disabled person's vehicle' has the same meaning as in Section 142(1) of the Act

'parking attendant' has the same meaning as in Section 63A of the Act

'relevant position' means

- (a) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon on the near side of and immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; and
- (b) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.

A vehicle displays a parking disc in the relevant position if:-

- (a) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter hour period during which the period of waiting began is legible from outside the vehicle; or
- (b) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter hour period during which the period of waiting began is legible from outside the vehicle.
- 3. Save as provided in Articles 6, 7 and 8 of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle to wait at any time in the lengths of Winton Crescent, Croxley Green specified in Schedule 1 to this Order.
- 4. Save as provided in Articles 6,7 and 9 of this Order, no person shall, except under the direction of or with the permission of a parking attendant or a police officer in uniform, cause or permit any vehicle to wait between the hours of 11am and 12 noon Monday to Friday (inclusive) in the lengths of Winton Crescent, Croxley Green specified in Schedule 2 to this Order.
- 5. Save as provided in Article 10 of this Order, no person shall, except under the direction of a police officer in uniform, cause or permit any vehicle to stop between the hours of 8am and 5pm Monday to Friday (inclusive) in the lengths of Winton Crescent, Croxley Green specified in Schedule 3 to this Order.

- 6. Nothing in Articles 3 or 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein for so long as may be necessary to enable:
 - a) a person to board or alight from a vehicle;
 - b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - i) building, industrial and demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said length of road;
 - iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
 - v) to a vehicle being used for fire brigade, ambulance or police purposes;
 - vi) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - vii) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.
- 7. Nothing in Articles 3 or 4 of this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle in any lengths of road specified in the Schedule to this Order at any time on any day.
- 8. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in Schedule 1 to this Order for a period of 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
- 9. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in Schedule 2 to this Order.
- 10. Nothing in Article 5 of this Order shall render it unlawful to cause or permit any vehicle to stop on the lengths of road specified in Schedule 3 in any case where the person in control of the vehicle:-
 - (a) is required by law to stop;
 - (b) is obliged to stop so as to prevent an accident; or
 - (c) is prevented from proceeding by circumstances beyond his/her control.
- 11. The relevant provisions of The Hertfordshire (Various Roads, Croxley Green) (Waiting Restrictions) (Consolidation) Order 2001 are hereby revoked.
- 12. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament.
- 13. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

SCHEDULE 1

Prohibit waiting "At Any Time"

From the south west junction of Winton Crescent with Winton Drive to a point 5m north west along Winton Crescent on the south side (adjacent to this junction). From the south west junction of Winton Crescent with Winton Drive to a point 5m south west along Winton Drive on the south side (adjacent to this junction).

From the south west junction of Winton Crescent with Winton Drive to a point 5m north west along Winton Crescent on the north side (adjacent to this junction). From the south west junction of Winton Crescent with Winton Drive to a point 5m north east along Winton Drive on the north side (adjacent to this junction).

From the north east junction of Winton Crescent with Winton Drive to a point 5m north west along Winton Crescent on the south side (adjacent to this junction). From the north east junction of Winton Crescent with Winton Drive to a point 5m south west along Winton Drive on the south side (adjacent to this junction).

From the north east junction of Winton Crescent with Winton Drive to a point 5m north west along Winton Crescent on the north side (adjacent to this junction). From the north east junction of Winton Crescent with Winton Drive to a point 5m north east along Winton Drive on the north side (adjacent to this junction).

SCHEDULE 2

Prohibit waiting 11.00 a.m. to 12 Noon Monday-Friday

At the south west junction of Winton Crescent with Winton Drive commencing from a point 5m north west from this junction on the north side (adjacent to this junction) to a point 5m north west from the north east junction of Winton Crescent with Winton Drive.

At the south west junction of Winton Crescent with Winton Drive commencing from a point 5m north west from this junction on the south side (adjacent to this junction) for a distance of 272m north west along Winton Crescent.

At the north east junction of Winton Crescent with Winton Drive commencing from a point 5m north west from this junction on the north side (adjacent to this junction) for a distance of 34m north west along Winton Crescent.

SCHEDULE 3

No Stopping 8am-5pm Monday-Friday

On Winton Crescent commencing from a point 39m north west of the north east junction of Winton Crescent with Winton Drive for a distance of 16m north west along Winton Crescent.
