THE THREE RIVERS (GREEN STREET, CHORLEYWOOD) (PARKING PLACES) (AMENDMENT NO.1) ORDER 2006

The Three Rivers District Council (hereinafter referred to as "the Council", pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hertfordshire County Council in exercise of the powers of the said County Council under Section 1(1), 2(1), 2(2), 3, 4, 32, 35 and 25C of the Road Traffic Regulation Act 1984, ("the Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, and all other enabling powers, hereby makes the following Order:-

- 1. This Order may be cited as "The Three Rivers (Green Street, Chorleywood) (Parking Places) (Amendment No.1) Order 2006" and shall come into operation on 20 March 2006.
- 2. The amendments to The Hertfordshire (Green Street, Chorleywood) (Parking Places) Order 2001 are referred to in this Order.
- 3. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment, save for where specifically stated.

SCHEDULE 1

Lengths of roads in Chorleywood - Residents Permit Parking Areas

No Waiting - Monday to Friday - 7.00am to 2.00pm. Except holders of Resident Parking Permits

Street Name	Side of Road	Location
Green Street East side Service Road	East	From a point approximately 13.5 metres from its junction with Green Street (northern end) south-eastwards for a distance of approximately 28 metres.
Green Street East side Service Road	East	From a point approximately 48 metres from its junction with Green Street (northern end) south-eastwards for a distance of approximately 99 metres.
Green Street East side Service Road	North	From a point approximately 153.5 metres from its junction with Green Street (northern end) north-westwards for a distance of approximately 19 metres.
Green Street West side Service Road	West and North	From a point approximately 16 metres from its junction with Green Street (northern end) south-eastwards for approximately 160.5 metres.

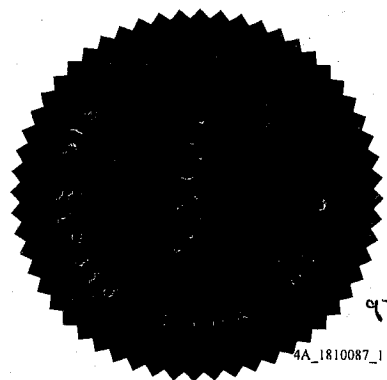
- 4. This Order hereby revokes Schedule 1 of The Hertfordshire (Green Street, Chorleywood) (Parking Places) Order 2001.
