

THE HERTFORDSHIRE (GALLOWS HILL LANE, BREAKSPEARE ROAD, POPES ROAD, GREENWAYS, TROWLEY RISE, OAK GREEN, CHERRY HOLLOW and TIBBS HILL ROAD, ABBOTS LANGLEY) (RESTRICTION OF WAITING) ORDER 2004

NOTICE is given that the Hertfordshire County Council have made an Order under Sections 1, 2(1) to (3) and 3 of the Road Traffic Regulation Act 1984 to introduce no waiting at any time on those lengths of road in Abbots Langley specified in the Schedule to this Notice.

The Order will come into effect on Monday 30 January 2006.

Exemptions to the waiting restrictions will apply as specified to enable persons to board or alight, for goods to be loaded and unloaded, for statutory duties or the emergency services, or for disabled persons vehicles to be parked, unless stated otherwise.

A copy of the Order together with a statement of reasons for proposing to make the order and plans showing the roads to which the Order relates, may be inspected from 26 January 2006 to 9 March 2006 at the offices of Three Rivers District Council, Three Rivers House, Northway, Rickmansworth; Abbots Langley Parish Council, Langley Road, Abbots Langley; and at Hertfordshire County Council's Room 223, County Hall, Hertford.

Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.

SCHEDULE

lengths of road in Abbots Langley – no waiting at any time

- Popes Road (north east side)
- (a) from its junction with the south east kerbline of Gallows Hill Lane south eastwards for 15 metres.
 - (b) from its junction with the north west kerbline of Breakspeare Road north westwards for 9 metres.
 - (c) from its junction with the south east kerbline of Breakspeare Road south eastwards for 6 metres.
 - (d) from its junction with the north west kerbline of Trowley Rise north westwards for 45 metres to a point in line with the boundary between 13 and 15 Popes Road.
- (south west side)
- (a) from its junction with the south east kerbline of Gallows Hill Lane south eastwards for 14 metres.
 - (b) from a point 17 metres north west of its junction with the north western kerbline of Greenways north westwards for 27 metres.
- Trowley Rise (north west side)
- (a) from its junction with the north eastern kerbline of Popes Road north eastwards for 16 metres.
 - (b) from a point in line with the boundary between 28 and 30 Trowley Rise north east and eastwards for 42 metres to a point 7 metres west of the boundary between 22 and 24 Trowley Rise.
- (both sides)
- (a) from a point 2 metres south west of the boundary between 102 and 104 Trowley Rise north eastwards for 30.5 metres to a point 2 metres west of the boundary of 96 and 98 Trowley Rise.
 - (b) from a point 2 metres north east of the boundary between 68 and 70 Trowley Rise north eastwards for 24 metres.
 - (c) from a point 9 metres north east of the boundary between 50 and 52 Trowley Rise north eastwards for 24 metres.

- (d) from a point 6 metres east of the boundary between 16 and 18 Trowley Rise eastwards for 24 metres.
- (e) from a point in line with the boundary between of 2a and 4 Trowley Rise eastwards for 33 metres to its junction with the western kerblines of Tibbs Hill Road.

- (south east side)
- (a) from its junction with the south west kerblines of Oak Green south westwards for 9 metres.
 - (b) from its junction with the north east kerblines of Oak Green north eastwards for 12 metres.
 - (c) from its junction with the north east kerblines of Cherry Hollow north eastwards for 11 metres.
 - (d) from its junction with the south western kerblines of Cherry Hollow south westwards for 11.5 metres.
 - (e) from a point in line with the boundary between 17 and 21 Trowley Rise south westwards for 59.5 metres to a point 4 metres north east of the boundary between 23 and 25 Trowley Rise.

Trowley Rise / Greenways (south east side) from a point in line with the boundary between 97 and 99 Trowley Rise south westwards to a point in line with the boundary between 1 and 3 Greenways, a distance of approximately 27 metres.

- Gallows Hill Lane (south east side)
- (a) from its junction with the south west kerblines of Popes Road south westwards for 5 metres.
 - (b) from its junction with the north east kerblines of Popes Road north eastwards for 7 metres.

Breakspeare Road (both sides) from its junction with the north east kerblines of Popes Road north eastwards for 5 metres.

Oak Green (both sides) from its junction with the south east kerblines of Trowley Rise south eastwards for 10 metres.

Cherry Hollow (both sides) from its junction with the south east kerblines of Trowley Rise south eastwards for 10 metres.

- Tibbs Hill Road (west side)
- (a) from its junction with the north west kerblines of Trowley Rise north westwards for 28 metres.
 - (b) from its junction with the south east kerblines of Trowley Rise south eastwards for 33 metres.
