THE THREE RIVERS (VARIOUS ROADS, CENTRAL AREA, CHORLEYWOOD) (WAITING RESTRICTIONS) (AMENDMENT NO.3) ORDER 2007

The Three Rivers District Council (hereinafter referred to as "the Council", pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hertfordshire County Council in exercise of the powers of the said County Council under Section 1(1), 2(1), 2(2), 3, 4, 32, 35 and 25C of the Road Traffic Regulation Act 1984 ("the Act"), and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order:-

1. This Order may be cited as "The Three Rivers (Various Roads, Central Area, Chorleywood) (Waiting Restrictions) (Amendment No.3) Order 2007" and shall come into operation on 2 April 2007.
2. The amendments to The Hertfordshire (Various Roads, Central Area, Chorleywood) (Waiting Restrictions) Order 2001 and The Three Rivers (Various Roads, Central Area, Chorleywood) (Waiting Restrictions) (Amendment No.2) are referred to in this Order.
3. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment, save for where expressly stated.

**SCHEDULE 1
Lengths of roads in Chorleywood - No Waiting at Any Time**

Street Name	Side of Street	Location
Station Approach	West	From a point 28 metres north of a point adjacent to the northern corner of the station building to the junction with Shire Lane, a distance of approximately 160 metres.

**SCHEDULE 2
Lengths of roads in Chorleywood - No Waiting - 8.00am to 6.00pm Monday to Saturday (inclusive)**

COLUMN 1	COLUMN 2	COLUMN 3
Street Name	Side of Street	Location
Station Approach	West	From a point 5 metres north of a point adjacent to the northern corner of the station building southwards for a distance of 13 metres.

4. The following provision of Schedule 1 of The Hertfordshire (Various Roads, Central Area, Chorleywood) (Waiting Restrictions) Order 2001 is hereby revoked.

Street Name	Side of Street	Location
Station Approach	West	From the junction with Shire Lane to a point approximately 185 metres south.

5. The following provision of Schedule 2 of The Three Rivers (Various Roads, Central Area, Chorleywood) (Waiting Restrictions) (Amendment No.2) Order 2006 is hereby revoked.

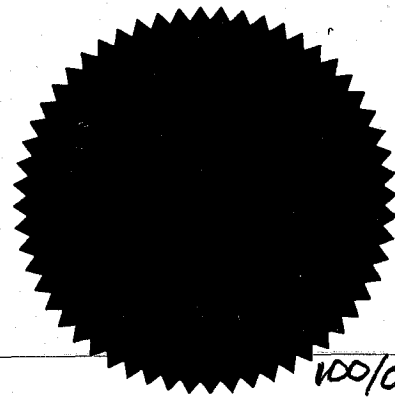
