**THE THREE RIVERS DISTRICT COUNCIL (THE WOODS, OXHEY DRIVE
AND PRESTWICK ROAD, SOUTH OXHEY) (WAITING RESTRICTIONS)
TEMPORARY ORDER 2007**

The Three Rivers District Council (hereinafter referred to as "the Council"), pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hertfordshire County Council in exercise of the powers of the said County Council under Section 14 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by Section 14 of the Road Traffic (Temporary Restrictions) Act 1991, hereby makes the following Order, because works are being executed on or near The Woods, Oxhey Drive and Prestwick Road, South Oxhey, Watford:-

1. This Order may be cited as "The Three Rivers District Council (The Woods, Oxhey Drive and Prestwick Road, South Oxhey) (Waiting Restrictions) Temporary Order 2007" and shall come into operation on 28 August 2007.
2. In this Order
 - 'disabled person's badge' has the same meaning as in Section 142(1) of the Act
 - 'disabled person's vehicle' has the same meaning as in Section 142(1) of the Act
 - 'parking attendant' has the same meaning as in Section 63A of the Act
 - 'relevant position' has the same meaning as Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000, as amended from time to time
 - 'vehicle' has the same meaning as Section 136(1) of the Act
3. The Council is satisfied that the execution of the works in question will take longer than eighteen months and this Order will remain in force until such time as the works are completed at which time the Council shall revoke the Order.
4. Save as provided in Articles 5, 6 and 7 of this Order, no person shall, except under the direction or with the permission of a parking attendant, cause or permit any vehicle to wait at any time in the lengths of The Woods, Oxhey Drive and Prestwick Road, South Oxhey, Hertfordshire specified in the Schedule to this Order.
5. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads specified therein for so long as may be necessary to enable:-
 - a) a person to board or alight from a vehicle;


-) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - i) building, industrial and demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or telecommunications;
 - v) a vehicle being used for fire and rescue services, ambulance or police purposes;
 - vi) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - vii) to enable the vehicle to be used in the service of the Post Office for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000

- 6. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle in any lengths of roads specified in the Schedule to this Order at any time on any day.
- 7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in the Schedule to this Order for a period of 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
- 8. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament.
- 9. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

SCHEDULE

Prohibit waiting "At Any Time"

On the north side of The Woods commencing from the junction of The Woods with Sandy Lane north-east along The Woods to the junction of The Woods with Oxhey Drive.

On the south side of The Woods commencing from the junction of The Woods with Sandy Lane for a distance of 92m north-east along The Woods.

On the west side of Oxhey Drive commencing from the junction of Oxhey Drive with The Woods for a distance of 95m north along Oxhey Drive.

On the east side of Oxhey Drive commencing from the junction of Oxhey Drive with Prestwick Road for a distance of 110m north along Oxhey Drive.

On the north side of Prestwick Road commencing from the junction of Prestwick Road with Oxhey Drive for a distance of 110m east along Prestwick Road.

On the south side of The Woods commencing from the junction of The Woods with Oxhey Drive South east along The Woods to the junction of The Woods with Prestwick Road.

On the south side of Prestwick Road from the junction of Prestwick Road with Oxhey Drive South for a distance of 99m east along Prestwick Road.
