## THE THREE RIVERS (TRAFFIC MANAGEMENT ACT 2004 AMENDMENTS TO OFF-STREET PARKING PLACES) CONSOLIDATION ORDER 2008


The Three Rivers District Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council ("the County Council") in exercise of the powers conferred by Sections 1 to 4, 32, 35 and 35C of the Road Traffic Regulation Act 1984 as amended from time to time ("the 1984 Act") and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and in accordance with the provisions of Part 6 of The Traffic Management Act 2004 ("the 2004 Act") and under all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

- 1. This Order shall come into operation on 31 March 2008 and may be cited as The Three Rivers (Traffic Management Act 2004 Amendments to Off-Street Parking Places) Consolidation Order 2008 (hereinafter referred to as "this Order").
- 2. The relevant provisions of the Road Traffic Regulation Orders specified in the Schedule hereto are hereby amended as indicated in Articles 3 to 6 (where applicable) herein.
- 3. Any reference to "parking attendant" shall have the same meaning as "Civil Enforcement Officer" as given in Section 76(5) of the 2004 Act.
- 4. Any reference to "Penalty Charge" and "Reduced Penalty Charge" shall have the same meaning as a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 of the 2004 Act.
- 5. Any reference to the enforcement of penalty charges or reduced penalty charges is hereby revoked and will now be regulated under the provisions of the 2004 Act.
- 6. All sums stated to be payable under any penalty charge in any article and/or schedule are hereby revoked and the driver shall pay a penalty charge as set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and as indicated in Schedules 1 and 3 of the Notice of Revised Penalty Charges for Parking Contraventions published by the Council and Watford Borough Council in March 2008 or such subsequent relevant Notices that the Council may publish.
- 7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
