PART I - PRELIMINARY

The Three Rivers District Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 3, 4 and sections 32, 35 and 35A of Part IV of the Road Traffic Regulation Act 1984 (as amended from time to time) "the Act" and under all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on [5 2007] 2008 or at a later date and may be cited as "The Three Rivers (Rickmansworth Park School Access Road, Rickmansworth) (Restriction of Waiting & Parking) Amendment No.1 Order 2008".
- The amendments to the Hertfordshire (Rickmansworth Park School Access Road, Rickmansworth) (Prohibition and Restriction of Waiting) Order 2003 are referred to in this Order (hereinafter referred to as "the 2003 Order").
- 3. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

4. ADDITIONS

4.1 The following additions are made to the 2003 Order creating new Schedules as referred:-

Schedule 4 - No waiting 2.00pm to 3.00pm Monday to Friday (inclusive)

Access road	West side	From a point 54 metres north west of its junction with the north western kerb line of Park Road northwards and westwards for 74 metres.
Street Name	Side of Street	Location
Column 1	Column 2	Column 3

Schedule 5 - Short stay parking (up to 1 hour) no return within 4 hours, Monday to Friday 8.30am to 4.00pm (inclusive)

Column 1 Street Name	Column 2 Side of Street	Column 3 Location
Access road	North side	The entire length of the lay-by adjacent to the northern boundary of the Rickmansworth Park JMI school.
