#### **PART I - PRELIMINARY**

The Three Rivers District Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 (as amended from time to time) "the Act" and under all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on [28<sup>rd</sup> march] 2009 or at a later date and may be cited as The Three Rivers (Rickmansworth) (Controlled Parking Zones) Amendment No.1 Order 2009.
- The amendments to the Three Rivers (Rickmansworth) (Controlled Parking Zones) Order 2006 (hereinafter referred to as "the CPZ Order") are referred to in this Order.
- 3. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.


