PART I - PRELIMINARY

The Three Rivers District Council (hereinafter referred to as "the Council") makes this Traffic Regulation Order pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council in exercise of the powers of the said County Council under Sections 1-4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended from time to time ("the Act") and of Part 6 of The Traffic Management Act 2004 and under all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1 CITATION AND COMMENCEMENT

- 1.1 This Order shall come into operation on 8 February 2010 or at a later date and may be cited as "The Three Rivers (Rickmansworth) (Controlled Parking Zones) Order 2006 Amendment No.1 Order 2010.
- 1.2 The amendments to The Three Rivers (Rickmansworth) (Controlled Parking Zones) Order 2006 (hereinafter referred to as "the 2006 Order") are referred to in this Order.
- 1.3 The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

PART II - REVOCATIONS AND ADDITIONS
