THE THREE RIVERS (WINTON DRIVE, SPRINGFIELD CLOSE, GIRTON WAY AND WINTON APPROACH, CROXLEY GREEN) (PARKING AND WAITING RESTRICTIONS) ORDER 2006 (AMENDMENT) NO.1 ORDER 2010

Made: 5 February 2010 Coming into operation: 8 February 2010 The Three Rivers District Council (hereinafter referred to as "the Council") makes this Traffic Regulation Order pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Authorities' (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council, and in exercise of the powers of the said County Council under Sections 1, 2, 3 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended from time to time ("the Act"), and of Part 6 of the Traffic Management Act 2004 and under all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act.

- 1 This Order shall come into operation on g February 2010 or thereafter and may be cited as "The Three Rivers (Winton Drive, Springfield Close, Girton Way and Winton Approach, Croxley Green) (Parking and Waiting Restrictions) Order 2006 (Amendment) No.1 Order 2010".
- 2 The amendments to the "The Three Rivers (Winton Drive, Springfield Close, Girton Way and Winton Approach, Croxley Green) (Parking and Waiting Restrictions) Order 2006" ("the 2006 Order") are referred to in this Order.
- 3 The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

## 4 **REVOCATIONS**

4.1 The following revocations are made to the 2006 Order at the Schedules referred:

SCHEDULE 1	Residents' Permit Parking Monday to Saturday (inclusive) 12 noon to 1pm, Except Bank Holidays	From a point 14m north east of the north west side of the junction of Winton Drive and Springfield Close for a distance of 37m north east along Winton Drive.
SCHEDULE 3	No Waiting At Anytime	From the north west side of the junction of Winton Drive and Springfield Close for a distance of 14m north along Winton Drive.

## 5 ADDITIONS

5.1 The following additions are made to the 2006 Order at the Schedules referred:

SCHEDULE 1	Residents' Permit Parking Monday to Saturday (inclusive) 12 noon to 1pm, Except Bank Holidays	From a point 25m north east of the north west side of the junction of Winton Drive and Springfield Close for a distance of 26m north east along Winton Drive.
SCHEDULE 3	No Waiting At Anytime	From the north west side of the junction of Winton Drive and Springfield Close for a distance of 25m north east along Winton Drive.
