THE THREE RIVERS (RICKMANSWORTH) (OFF STREET PARKING PLACES) ORDER 2006 (AMENDMENT No. 1) ORDER 2012

The Three Rivers District Council ("the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- This Order may be cited as the Three Rivers (Rickmansworth) (Off Street Parking Places) Order 2006 (Amendment No. 1) Order 2012 [this order] and shall amend the Three Rivers (Rickmansworth) (Off Street Parking Places) Order 2006 [that order or the order of 2006] and shall come into operation on 1st October 2012.
- 2. The order of 2006 shall have effect as though:
 - a)schedule 4 of that order were substituted by schedule 4 of this order.
 - b)schedule 5 of that order were substituted by schedule 5 of this order.
 - c)schedule 7 of that order were substituted by schedule 7 of this order.
- 3. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.

- An operational vehicle(s) registered to the business, and
- Are registered for business rates.

Operational vehicles are vehicles that are essential to a business because they are needed for deliveries and collections on an intermittent daily basis. Vehicles that are simply used for getting to and from work do not qualify as operational vehicles.
