THE THREE RIVERS (VARIOUS ROADS, CHORLEYWOOD OUTER AREA) (PARKING PLACES) ORDER 2006 (AMENDMENT No. 4) ORDER 2014

The Three Rivers District Council (hereinafter referred to as "the Council"), pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as The Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 (Amendment No. 4) Order 2014 (hereinafter referred to as "this order") and shall amend the Three Rivers (Various Roads, Chorleywood Outer Area) (Parking Places) Order 2006 (hereinafter referred to as "the order of 2006") and shall come into operation on 1 November 2014.
2. The Order of 2006 is hereby amended as follows:

- a. The List of Schedules shall be amended to read:

Schedule No.	Description
1	Residents' Permit Parking Monday to Friday 10am to 11am, Except Bank Holidays
2	Residents' Permit Parking Monday to Friday 11am to 12 noon, Except Bank Holidays
2A	Residents' Permit Parking Monday to Saturday 9am to 5pm, Except Bank Holidays
2B	Unmarked Residents' Permit Parking Monday to Friday 11am to 12 noon Except Bank Holidays
3	Medium Stay Parking Places, up to 4 hours parking, Monday to Friday 9am to 5pm
4	Parking places for Authorised Disabled Person's Vehicles
5	Qualifying Addresses
6	Permit Charges

- b. All references to "Parking Attendant" shall be amended to read "Civil Enforcement Officer".

c. Article 3 shall be amended to read:

3.

- (1) Each of the lengths of road specified in Schedules 1, 2, 2A, 2B, 3 and 4 which shall be bounded on one side of that length by the edge of the carriageway, is hereby designated as a parking place.
- (2) Each area on highway within a parking place and marked out for the purposes of parking in accordance with the provisions of this Order is hereby designated as a parking bay.

d. Article 5 shall be amended to read:

5.

- (1) Subject to the provisions of this Order, parking places may be used for the leaving during permitted hours of vehicles of the following class, that is to say, passenger vehicles, goods vehicles (the overall height of which does not exceed 2.3 metres and the overall length of which does not exceed 5.25 metres), motor cycles and invalid carriages.
- (2) Parking places referred to in Schedules 1, 2, 2A and 2B may be used for the leaving during permitted hours as specified in the title to each schedule of such vehicles of the class specified in article 5 (1) above –
 - (a) when a valid resident's permit issued in respect of that vehicle is displayed in the manner specified in Article 20; or
 - (b) when a valid resident's visitor's permit is displayed in the manner specified in Article 28(1); or
 - (c) when a valid special permit issued in respect of that vehicle and that parking place is displayed in the manner specified in Article 34.
- (3) Parking places referred to in Schedule 3 may be used for the leaving during permitted hours of vehicles of the class specified in Article 5 (1), however no person shall cause or permit any vehicle to wait in the parking places referred to in Schedule 3 –
 - (a) for a longer period than 4 hours
 - (b) if a period of less than one hour has elapsed since the termination during permitted hours of the last period of waiting (if any) of that vehicle in that parking place
- (4) Parking places referred to in Schedule 4 may be used for the leaving during the permitted hours of vehicles of the class specified in Article 5 (1) when a valid disabled badge in respect of that vehicle is displayed in the manner specified in Article 2 (4).

e. Article 10 shall be amended to read:

10. Every vehicle left in a parking place in accordance with the foregoing provisions of this Order shall so stand in the case of a parking place in relation to which special provisions as to the manner of standing of a vehicle in that parking place are specified in column 3 of Schedules 1, 2, 2A, 2B, 3 and 4 as to be in accordance with those provisions.

f. Article 14 (a) shall be amended to read:

14.

(a) In the case of a parking place in relation to which special provisions as to the manner of standing of a vehicle in that parking place are so specified in Schedules 1, 2, 2A, 2B, 3 and 4 so that the vehicle shall stand:

(i) in accordance with those provisions and so that every part of the vehicle is within the limits of the parking place, unless the width of the vehicle precludes compliance with this requirement; or

(ii) if the width of the vehicle does preclude compliance with the requirement in Article 14 (a) (i), so that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the vehicle and that edge shall not be greater than 300 millimetres

g. Article 15 shall be revoked in its entirety.

h. Article 16 (2) shall be revoked in its entirety.

i. Article 21 (5) shall be amended to read:

(5) The charge referred to Article 21 (3) shall be as specified in Schedule 6.

j. Schedule 1 shall be revoked in its entirety and Schedule 1 below inserted in its place.

k. Schedule 2 shall be revoked in its entirety and Schedule 2 below inserted in its place.

l. Schedule 2A shall be revoked in its entirety and Schedule 2A below inserted in its place.

m. Schedule 2B below shall be inserted immediately following Schedule 2A.

n. Schedule 4 shall be revoked in its entirety and Schedule 4 below inserted in its place.

o. Schedule 5 shall be revoked in its entirety and Schedule 5 below inserted in its place.


p. Schedule 6 below shall be inserted immediately following Schedule 5.

3. The Traffic Regulation Orders set out in Schedule 7 below are hereby revoked in their entirety.

4. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.

Schedule 1: Residents' Permit Parking Monday to Friday 10am to 11am, Except Bank Holidays

Item no	Street name	Side of street	Location
1	Shire Lane Service Road	North-west	From a point opposite the common boundary of 14 and 15 Shire Lane south-westwards to a point opposite the common boundary of 30 and 31 Shire Lane (a distance of approximately 222 metres).
2	Hillside Road	North-east	From a point 10 metres south of its junction with Shire Lane south-eastwards for a distance of 22 metres.
3	Hillside Road	North-east	From a point 10 metres south-east of its junction with Berks Hill south-eastwards for a distance of 30 metres.
4	Berks Hill	North	From a point 70 metres south-west of its junction with Hillside Road south-westwards for a distance of 38 metres.
5	Berks Hill	North	From a point 22 metres south-west of its junction with Haddon Road south-westwards for a distance of 50 metres.
6	Berks Hill	South	From a point 33 metres south-west of its junction with Hillside Road westwards for a distance of 190 metres.

1	Berks Hill	South	From a point 15 metres north-east of its junction with Hillside Road north-eastwards for a distance of 267 metres.
2	Capell Road	South-east	From a point 10 metres north-east of the north-eastern kerbline of Copmans Wick north-eastwards for a distance of 130 metres.
3	Capell Road	North-west	From a point opposite the common boundary of 30 and 32 Capell Road south-westwards for a distance of 126 metres.
4	Capell Way	East	From a point 10 metres north of the north-western kerbline of Hubbards Road northwards for a distance of 60 metres.
5	Capell Way	West	From a point 6 metres south of the common boundary of 2 and 4 Capell Way southwards for a distance of 15 metres.
6	Hubbards Road	South-east	From a point opposite the common boundary of 9 and 11 Hubbards Road north-eastwards for a distance of 60 metres.
7	Hubbards Road	North-west	From a point 15 metres southwest of the south-western kerbline of Capell Way south-westwards for a distance of 120 metres.
8	Quickley Lane	North	From a point 30 metres west of its junction with Lower Road westwards for a distance of 100 metres.
9	South Road	South-west	From a point 15 metres north-east of its junction with Hillside Road north-eastwards for a distance of 267 metres.
